COUNCIL PROTESTS UNION TRAINING PROGRAM

Council's Chairman, Peggy J. Smith which is being directed to the Culinary Worker Local No. 226, with copies to the NAACP, Southern Nevada Human Relations Commission, Nevada Equal Rights Commission, Fair Practice and Training Council, Economic Opportunity Board, State Department of Welfare, Youth Opportunity Center, City Commissioners, District Administrator of Welfare, U. S. Civil Rights Commission, and the local new media.

To Whom It May Concern:

There is a current program in Clark County under a project sponsored by the Culinary Union Local 226 AFL-CIO for the purpose of training for the hotel industry. This program is funded, in part, by the Federal Government, however; thus far, this union has been accepting Negro applicants for training as maids, porters and kitchen helpers.

Needless to say, this present practice is discriminatory; designed not to prepare the Negro for the labor market or to increase his earning capacity. It is designed to maintain and continue the age-old practice of servitude, and relegating menial jobs to Negroes. We grant that some training is necessary in the abovementiond categories, but we also maintain that it would hardly consist of little more than "on the job" instruction as to when and where these duties are to be performed. The know-how is already there.

raining the Culinary Union is offering is not fulfilling the aim of the War on Poverty Program. Maids, dishwashers and porters in our area have large families and the wages they receive definitely puts them on the poverty

"The central problem is to protect and re-store mans' satisfaction in belonging to a community where he can find security and significance," said our President. OEO Civil Rights Regulations require that no person in the United States shall on grounds of race, color or national origin be excluded from participation in, be denied the benefits of, or be other-

The Matt Kelly Neighborhood Council has wise subjected to discrimination under any made public the following letter signed by the program which this part applies. Consideration of race, color or national origin may not influence the conduct or administration of any aspect of the Community Action Program.

These regulations not only prohibit direct discrimination, such as the use of racial quotas, but indirect discrimination, such as limiting the extension of program benefits to groups which are selected by reference to race, color or national origin.

We are interested in the economic development of the people in our community. We are not happy with the few token jobs the Union has provided.

We feel the program is not a broadly based one and we are asking the Union, if possible, to develop a training program of larger scope which would adhere to the standard of the community action program.
