

# Complete DEMO CARAVAN PARTICIPANTS LIST

Friday's Democratic Caravan Rally in the Golden West Shopping Center's Parking Area is the second stop in a state-wide Caravan which was kicked off today (Thursday) in Beatty and will end in Reno, October 2.

It is expected that thousands of Nevadans will greet the Caravan as it makes the scheduled stops to give opportunity to voters to meet and chat with Democratic candidates at all elective levels.

TOMORROW'S RALLY will be headed by United States Senators Alan Bible and Howard Cannon and Governor Grant Sawyer, and it is urged that West Las Vegas make it a point to be on hand at the Golden West Shopping Center between the hours of 7 and 9 p.m. to clearly demonstrate their support of Governor Sawyer for re-election.

## Right Guy For Tough Job

Donal (Mike) O'Callaghan, former top-ranking Federal and State official and a close runner-up in the Democratic Primary for Lieutenant Governor, has been named 1966 Campaign Coordinator for the Nevada Democratic Central Committee, Chairman William Macdonald announced.

Macdonald said O'Callaghan, 37, will begin immediately to coordinate the activities of the State and County Central Committees and the Campaigns of State Democratic Nominees. This is the first time in the history the Party has named a full-time Campaign Coordinator.

"The Party is very fortunate to have Mike's services for this Campaign," Macdonald said in Winnemucca. "He is a brilliant organizer, respected throughout the State and the type of dynamic personality we want in the forefront of this Campaign."

Macdonald said the choice of O'Callaghan was endorsed by all nominees on the State Ticket. He noted the Campaign assignment would end with the General Election Nov. 8, and said it should not be confused with the oft-discussed position of Executive Secretary of the Party.

The Party Chairman added that O'Callaghan had turned down attractive job offers from Industry and Government following the Primary in order to devote full time to the Campaign.

Governor Sawyer said he was pleased to learn of O'Callaghan's acceptance and looked forward to working with him.

"Mike is held in the highest esteem by all of us," the Governor said. "He has a sure Political touch and a personal drive that will help keep the Campaign in high gear."


John Foley of Las Vegas, Democratic nominee for Lieutenant Governor, praised the selection of O'Callaghan.

"I have worked with Mike in many campaigns," he said, "and I feel he will make a real contribution toward a complete Democratic victory all the way down the line."

## Apprenticeship Program Discrimination Charged

Mr. Leonard H. Carter, NAACP West Coast Regional Director and Mr. John Cope, Publicity Chairman of the Watts Branch of the NAACP in Los Angeles, California, appeared before the Apprenticeship Standards Committee, a subcommittee of the California State Assembly's Industrial Relations Committee.

Mr. Carter and Mr. Cope stated that there is massive racial discrimination in the Apprenticeship Training programs and that of 240,224 Negroes in the Bay Area, only 242 were in the Apprenticeship Training programs as of 1964. Mr. Carter pointed out the serious lag of Negroes admittance to certain skilled crafts apprenticeship programs, and stated that much remains to be done to end all discrimination in the apprenticeship crafts.

The NAACP offered a list of recommendations which they believe will help to eliminate racial discrimination in the apprenticeship training programs. Among those recommendations was the suggestion of the formation of an information program consisting of dispensing and posting information on examinations in high schools, and holding seminars and job fairs be set up. Other suggestions included: yearly ethnic surveys; decertification and deregistration

of apprenticeship programs practicing racial discrimination; withholding of funds from apprenticeship programs lacking standardized entry procedures; the funding of vocational schools to train students in the apprenticeship program's skills and crafts; and the establishment of an office of Contractual Compliance to eliminate discrimination in state issued contracts.

In closing, Mr. Carter said, "The Apprenticeship Law in California must be strengthened if we are to be successful in our goal of ending racial discrimination and exclusion. The Apprenticeship Law in California, Chapter 1 of Division 2, entitled, "Apprentices on Public Works," Section 1777.6 reads as follows:

"It shall be unlawful for an employer or a labor union to refuse to accept otherwise qualified employees as indentured apprentices on any public works, solely on the ground of the race, creed, national origin or ancestry, or color of such employee."

"I propose that this section be amended to make non-compliance a misdemeanor or a felony. As the law is presently written the penalty is insufficient to compel compliance."
