guided the state of Nevada through a period of unprecedented growth and prosperity.

The chief executive has handled himself and the problems of the state well. He has pushed for tougher law enforcement. He has conducted a relentless search for new industry for the state of Nevada and worked for the improvement of all of the state in-

On several occasions during his two terms in office, the Governor has stood pat against the forces of big government. He has battled for the right of Nevada to handle its own affairs. Most recent of his attempts to prevent infringement on states rights by the federal government in his outspoken attack on the Federal Bureau of Investigation. He has demand-ed that J. Edgar Hoover, FBI Director, produce evi-dence to support his claim that Nevada gambling plays a major role in the nation's organized crime and racketeering.

Gov. Sawyer has stood his ground on this vital issue and on others.

He was one of the first public officials in the state to take a position on the rights of minority races in Nevada. He met repeatedly with Negro leaders and played a major role in the passage of the state's first civil rights law. Consequently, Sawyer was instrumental in the creation of the Nevada Equal Rights Commission.

The Governor attained a degree of national stature by serving simultaneously as chairman of the Western Governors' Conference and Chairman of the National Governors' Conference. He has been granted audiences with both Presidents John F. Kennedy and Lyndon B. Johnson. Furthermore, Sawyer has indicated an ability to work with members of the state's congressional delegation in Wash-

As chief of the Democratic administration in Carson City, Sawyer took significant steps in streamlining state government. His reorganization plan, the bulk of which was approved by the legislature, combined many of the state boards and commissions into manageable super agencies. Such a plan was long overdue.

Sawyer is seeking an unprecedented third term. There are those who believe it is time for a change, that Republican Lt. Gov. Laxait should succeed Sawyer in the statehouse.

We question the idea of change for the sake of change and endorse Grant Sawyer's bid for reelection. He has been a good governor and little evidence has been offered to indicate that he will not continue to serve the state as he has during the past eight
