**CORE BROKE BUT ALIVE**

NEW YORK--(NPI)--"Rumors of our death have been greatly exaggerated," Floyd B. McKissick, CORE's executive director, said, as he met with the organization's creditors to settle debts.

Denying the group faced bankruptcy, although it seeks to pay off its bills at 25 cents on the dollar, he said. "We can operate on our income, but we can't manage to pay off our creditors as fast as we would want to."

The "high cost of demonstrations," has tied close to \$300,000 in bail bonds in the South. CORE's current income of \$26,000 a month about equals its expenses.

**Powell Opponent Tries**

NEW YORK--(NPI) -- Rep. Adam Clayton Powell (D-N.Y.) faced the prospect of being jailed regardless of where he may have gone, as the New York Supreme Court ordered that he serve 30 days in jail. The only trouble was that no one knew where Powell was.

The court order was one of many judgements directed against the Harlem Congressman as a result of a libel judgment against him. The State Supreme Court found him guilty of two counts of criminal contempt.

Unlike the civil contempt citations issued against Powell, the latest order can be served outside New York state. While Powell's whereabouts were not known, he was expected to appeal the sentence.

Supreme Court Justice Matthew M. Levy had said the court would wait until the national elections before issuing the order. The order grew out of Powell's characterization for corrupt policemen on a 1961 television program.

The Justice ordered Powell to pay a \$250 fine and serve a 30-day jail sentence on each of the two counts. The jail sentences would run concurrently. Powell was not in court, but was represented by five attorneys.

Meanwhile, the Harlem Congressman's Republican opponent in the Nov. 8 election charged that Powell was not a resident of the state and therefore was ineligible to hold office. The suit, filed in the State Supreme Court by Lassen L. Walsh, was clearly an attempt to force Powell to come to court--and face arrest. "Can I help it if he's arrested?" Rubin shrugged.
