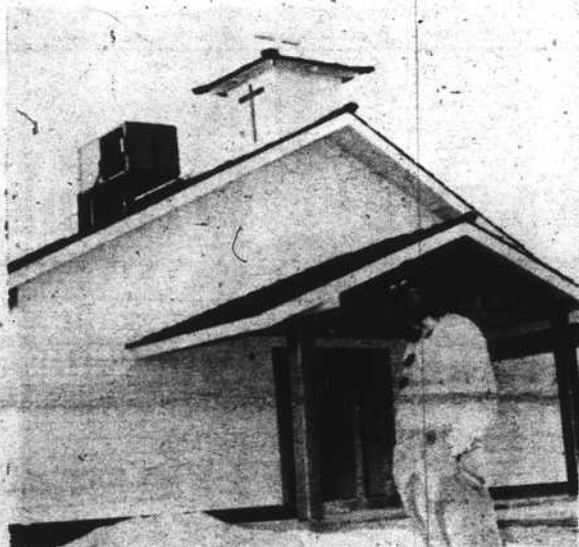

ON THE HIGHEST point in the Windsor Park development, a fairy story white church is nearing completion. Sometime before Christmas, this fairy tale will become reality when the Reverend Prentiss S. Walker delivers a "Sermon on the Mount" to his Greater Faith Baptist congregation.

I never saw a house of worship that looked so exactly like my childhood image of a little white church with a cross perched on its roof, high above its entrance. Nor, do I remember a better setting for the church of my childhood dreams.

The Greater Faith Baptist Church sits upon a little knoll which overlooks the Las Vegas Valley. It is perched majestically upon the very highest point in the western sector of North Las Vegas.

PERHAPS THE brightest thing about this little dream of a church is the fact that it is all paid for except for a small lien held against the heat pump which will keep the parishioners comfortable in all seasons. An even greater comfort will come from the security of knowing that their church is theirs and is all paid for.

The Loner, Rev. P. S. Walker, did it as he has done most things, alone.

Governor-elect's "New Look" For Nevada

Nevada's Governor-elect, Paul Laxalt, who campaigned on a "New Look for Nevada", in identifying his task force to implement the program as outlined at a recent press conference here in Las Vegas, did, in fact, introduce an unusual new concept.

Speaking on the subject of Civil Rights, Laxalt said, "In the whole area of civil rights as far as I'm concerned Woodrow Wilson will supplant the existing leadership, if there is any in west Las Vegas."

It is believed to be the first time a government head, municipal, state or federal, has chosen to utilize an elected official in a position conventionally held by a staff member to serve the governmental head's interest in a given specified area. It is also the first time a head of state has ventured to designate leadership for an ethnic group.

Wilson, one of nine successful candidates to win the right to represent the constituency of Nevada's 4th Assemblymatic district in the State Legislature, garnered upwards of 18,000 votes at the polls.

The Governor-elect also announced his intention "to return the Equal Rights Commission

to its original purpose, one of acting as a conciliation board and not one which hands out compulsory decisions". He added "I will be looking very carefully at any additional legislation...As you know, my general view of the matter has always been that there is already too much legislation nationally and locally".

Mr. Laxalt should not be surprised to know that his views of a surfeit of legislation, particularly on the local level, are not shared by those in whose interests such legislation is intended. His opinion that the Equal Rights Commission was intended to act as a conciliation board is also considered at variance with the general interpretation of its purpose inasmuch as the Commission was established to implement Nevada's 1965 Civil Rights Act.

In view of Governor-elect Laxalt's expressed desire to enhance the state's 'image', hope has been expressed that Nevada's incoming Governor will give even more careful thought and consideration to his proposal to devitalize the Nevada Commission on Equal Rights of Citizens. Consensus of opinion is that the Commission, to be effective should be granted additional powers, not weaker ones.
