Administrative Post For Matt Kelly Teacher

Former Matt Kelly Elementary School instructor John Bass, 30, has been named Coordinator of Title I Projects of the Clark County School District. The appointment was made late last month and will continue through the remainder of the current school year.

BASS, WHO has taught both third and fourth grades at Matt Kelly under Principal John Walker, will work directly with Dr. Joseph Caliguri, District Director of Equal Educational Programs.

"We are very pleased to have Bass on our staff," Dr. Caliguri said, "He's an outstanding teacher and understands many of the challenges facing our public schools located on the Westside."

Locally-controlled Federal funds under Title I of the Elementary and Secondary Education Act (ESEA) provide monies to carry out extensive compensatory education programs throughout the Clark County School District. BASS' CURRENT main responsibility is to

BASS' CURRENT main responsibility is to see that the aims and objectives of this program are working smoothly at six Westside elementary schools which employ 19 teachers and 7 teacher aides in the project; Bass coordinates the purchase of educational materials including audio-visual aids, textbooks and teaching supplies. Bass and Dr. Verdun Trione of Nevada Southern University handle the in-service education of teachers to make them more familiar with the needs of disadvantaged youngsters living in areas having high concentrations of low income families. NSU is providing facilities without charge through Dr. Donald Moyer, Chancellor.
