VOICE Publisher Kin May Be Pa. Health Chief

Dr. Wilbur Strickland of Philadelphia, brother-in-law of VOICE publisher, Dr. Charles I. West, is reported to be the strongest contender for the Cabinet post of State Secretary of Health in Pennsylvania according to a front page story appearing in the December 10 issue of the Philadelphia Tribune. IN A statement to the Tribune, Dr. Strickland

said that he had received no official word on the possibility of the appointment that would make him the first Negro to hold the position, but added, 'I am flattered and pleased to learn that I am being considered'. Information that the 63-year-old Philadelphia doctor was a prime prospect for the appointment is said to have come from observers close to State House of sources in Harrisburg,

Dr. Strickland, a specialist in internal medicine and a devoted advocate of preventive mediphia's Mercy-Douglass Hospital and Grand Medical Director of the IBPOE of the World. (Las' Vegas' Dr. Charles I. West is IBOPE's Deputy Grand Medical Director).

The Philadelphia doctor has an imposing record of public service. During World War II, he interrupted a lucrative practice to volunteer for services overseas, and became the first Negro in United States history to command a base hospital. From 1943 to 1946, he was in charge of an army hospital in Burma in Southeast Asia.

IN 1955, Dr. Strickland became Pennsylvania's first Negro Athletic commission physician; a post he has held under three governors and in which he continues to serve as a fourth ad-". • ministration prepares to take over. He is also a member of the Board of Directors of Philadelphia's Fellowship House and Wharton Settlement.

During his five years as Grand Medical Director of the Elks, Dr. Strickland has organized a mammoth program of alerting the public to the medical and diagnostic services which are available to them in their communities. It is his deep-seated conviction that many cases of cancer and other illnesses could be success-fully treated if people took full advantage of free health services already established.

Dr. Strickland was born in Philadelphia on May 20, 1903; the son of the late Dr. George D. Strickland, who had graduated from Howard

Medical School. In 1928, the young Dr. Strickland married a sister of Dr. Charles West of Las Vegas, the former Charlotte West of Washington, D.C., the daughter of his anatomy professor at Howard where he also studied.
