LOMAX IN TOP SPOT AS PEACE NEGOTIATOR

LOS ANGELES - (NPI) -- Author Louis Lomax's visit to North Viet Nam could be instrumental in arranging a peace settlement between the United States and the Communist country,

it was revealed last week.

LOMAX, IT WAS noted, is the first American
to go to North Viet Nam with a valid passport.
The country is ordinarily off limits to American citizens.

In North Viet Nam, Lomax could turn out to be a valuable contact between the country's Communist rulers and the American officials. Since Lomax will be in North VIET Nam, not as State Department representative nor a violator of U.S. passport regulations, he will be in a position to be an impartial "go-between" between the U.S. and North Viet Nam governments.

His being a Negro, in a Far East country which is itself non-white, could also help thaw North Vietnamese officials and move them toward consideration of peace terms. Lomax was to visit North Vietnamese President Ho Chi Minh and Premier Pham Van Dong, among

While he was briefed by U.S. officials before left, he stressed that he was not an "agent of the State Department."

Famed Negro Architect Designs Air-Cab System

LAS VEGAS - (NPI) -- An "air-cab" transportation system which could revolutionize the nation's transit systems has been designed by a noted Negro architect.

Paul R. Williams of Los Angeles, has designed a system calling for building a 17-1/2 mile elevated network. Tiny four-passenger gondolas, capable of speeds up to 30 miles an hour, would be suspended from the network.

THE SYSTEM could carry 16,000 passengers an hour to 15 separate stops. It would link the city's downtown center with McCarran Airport. The air-cab idea is expected to be copied by other cities having traffic congestion problems.

promoters of the system say.

"From its first day of operations, the cab will instantly remove untold amounts of congestion from the sidewalks and roadways of Las egas," the backers said.

Williams has designed such West Coast landmarks as the Los Angeles International airport, Saks Fifth Avenue of Beverly Hills, the County of Los Angeles House, and the Botany building at the University of California, Los Angeles.
