Last Sunday's program at Doolittle Center, so excellently presented for the purpose of installing officers of the local branch, re-vealed an unexpected involvement of community figures and portended an unprecedented zeal among Las Vegas Negroes to close ranks in solidarity to achieve, through the NAACP, a future of justice and equality for the Negro.

Co-chairman of the auspicious occasion, Mrs. Sarah Ann Knight and Mrs. Virgie Fitz-gerald, expressed delight and gratitude to both their committee members and all others who worked so assiduously to make the event the success it unqualifiedly was.

ATTORNEY Charles Kellar, who heads the new regime which includes LaMar McDaniel, 1st Vice President; Rev. Marion D. Bennett, 2nd Vice President; Floyd Plymouth, Secretary, Stella Fears, Ass't Secretary; and Attorney Earle White, Jr., Treasurer, named 15 committee heads to insure implementation of the 67-'68 program of the local branch.

In his acceptance speech, Kellar noted four immediate goals for the local branch...(1) That everyone in the community will become active in the struggle. (2) Quality education for every child. (3) More and better jobs in every facet of employment for the Negro in Las Vegas. (4) Removal of every vestige of police disrespect for the Negro citizenry.

Already scheduled for the organization is a Freedom Fund Banquet to be held February 13 at the Mint Hotel with Jackie Robinson as Guest Speaker. Jimmy Gay is in charge of arrangements. On February 19, at the next regular meeting of the local branch, Dr. Charles I. West will speak on "Black Power--What Does It Portend For the Negro?'.
