agency owning or maintaining the building is guilty of misdemeanor, unless such person can show that he was engaged in or pursuing lawful business in such building or property at the time" and that the Bill defines "public agency" as the state of Nevada, any agency or instrumentality of the state, and any political subdivision of the state, there is clearly reason for concern in that many organizations utilize "public agency" properties for meetings, and obviously, not during regular business hours of that agency, and that the Bill provides no protection for "organizations" against arbitrary decisions of those persons designated by authorization to remove them from the property.

ATTORNEY Charles L. Kellar dispatched a telegram to the Clark County Delegation of the State Senate requesting tabling of all three Bills pending Senate's receipt of formal request for public hearings on the controversial Bills. Dr. Chas. I. West, Publisher of the Las Vegas VOICE and the Neighborhood Councils have similarly registered protests against the Bills and requested the Clark County Delegation to strive for tabling of Bills and support petition for public hearings on them.

On the local front, the NAACP has authorized Lamar McDaniel, chairman of the organization's Labor and Industry Committee, to immediately engage his committee in a survey of present minority employment in the local hotel and casino industry.

NAACP President, Attorney Charles L. Kellar stated "It is absolutely essential that the NAACP learn what specific efforts the hotels have made to integrate and upgrade Negroes and what additional efforts must be made to bring the hotels into compliance with the Federal Civil Rights Act."
