AS WAS EXPECTED, Sunday's Installation-Luncheon of the Democratic Women's Club-West at the Showboat Hotel, attracted the "Party" elite as well as a few of the organization's fans from the opposition Party.

President of the Clark County Democratic Central Committee acknowledged the presence of distinguished guests, among whom were Nevada's senior U.S. Senator Alan Bible who congratulated the incoming officers and made a few remarks.

Assemblywoman Flora Dungan (Clark County) as principal speaker of the event was, unquestionably, the hit of the afternoon. A warm reception greeted introduction of the "people's champion" and the rapport between the Assemblywoman and the audience was remarkable.

## Reagan Negro Appointee Opposes Fair Housing Act

SACRAMENTO, Calif. - (NPI)--The first Negro department head in California's history has come out against the embattled Rumford Fair Housing Act.

James E. Johnson, the State's Veterans Affairs director, said he would "prefer to get rid of the whole concept of the (Rumford) act and work out a new, effective workable open housing law."

That law, he said, "would not infringe on the minority's right to have a home, and, at the same time, would not infringe on the rights of the majority."

JUST PASSING a bill means little, he said.

"We have to have a law that limits both parties to the same degree. But the whole thing is a matter of attitude, and we must solve the attitude problem."

In taking issue with the Rumford Act, Johnson was following the line of the man who appointed him, Gov. Ronald Reagan. Johnson worked as one of Reagan's finance chairmen during the gubernatorial campaign.

The Fair Housing Act, being appealed in the U.S. Supreme Court by the State's realtors, faces the possibility of being repealed by the State Legislature.

## Anti-Negro Nazi Fan Shoots Up Chicago School

CHICAGO - (NPI)--A white boy who shot up a local high school has been revealed to have been an avid reader of Nazi literature and an opponent of racial integration among students at his school.

Donald Ayen, 18, faced federal and local charges of shooting up integrated Waller High School's auditorium on the near Northside. The youth blamed Negro members of a teenage gang at the school for goading him into committing his frenzied act of terror.

No one was injured in the shooting, which damaged the ceiling and several chairs in the auditorium. The shooting spurred Mayor Richard J. Daley and others to urge passage of stronger gun laws.

POLICE SAID they found a pile of "Rockwell stuff" in the boy's bedroom. That was a reference to George Lincoln Rockwell, head of the American Nazi Party. Also found were what police described as a pair of "storm trooper's" boots.

Local Nazi leaders said they had not heard of Ayen. He could have gotten his literature from Arlington, Va., national Nazi headquarters, they added.

Ayen was defended by his mother, who described him as "such a good boy." Her son, she said, became physically ill when he saw a white girl and a Negro boy going together. He complained of such a feeling the night before the shooting, she added.

Ayen told police his desperate act was spurred by repeated acts of harassment by members of a Negro gang at the school.

AFTER BEING badgered for money, the white boy brought 1,050 rounds of ammunition, a .30-caliber carbine modified for automatic use, and a gas mask to school. The gas mask was to be used, he explained, if police tried to "smoke" him out with tear gas. The mask was never used.

The boy went to the school auditorium, where he hoped to ambush his black foes, police said. Instead, he was spotted by a student who noticed his weapon. A scuffle ensued, and a teacher was called to the scene.

Ayen, police said, lined students and a teacher against the wall. Then his attention was distracted. The teacher ran. Ayen reportedly ran after him, and fell. The automatic weapon went off, firing six shots into the chairs and ceiling.

Called to the scene, police were warned by the youth not to come closer. But they finally coaxed him into giving up.

## Same Housing Act Gets Administration Backing

WASHINGTON - (NPI)--The Johnson administration has lent its weight to efforts to save the embattled Rumford Open Housing act.

Solicitor General Thurgood Marshall urged the U.S. Supreme Court to rule that a state may not "enshrine" in its Constitution the "right" to discrimination.

In a friend-of-the-court brief, Marshall asked the justices to affirm a California Supreme Court ruling that struck down a 1964 referendum vote repealing the state's open housing laws.
