How About This GEORGE WALLACE ON NEVADA '68 BALLOT

MEMBERS OF the Independent American Party of Nevada must be dancing on their ovens. Having petitioned to participate in the Primary Election as qualified electors of the State of Nevada, equalling in number at least five percent of the entire vote cast in the state of Nevada for representative in Congress at the last preceding general election, November 1966, their first big push is on.

At hand is a May 12 dated release, to wit: "The Nevada Wallace For President Committee is proud to announce the official approval of Secretary of State John Koontz of the petition which will place the name of George C. Wallace on the ballot as Presidential candidate for the United States in 1968.

"The Committee has begun circulation of petition in Northern Nevada and is in the process of establishing a Clark County office.
"An official kickoff of the Wallace for Pres-

ident movement is planned in the near future. "The Nevada Committee is now correspond-

ing with Wallace to bring him to our great State to expound the principles of Constitutional gov-

"The Nevada Committee is in contact with the various State and the National Wallace fo. President Committee.'

IN THE state's third party's petition to the Secretary of State, the organization outlined the "principles" of the Independent American Party of Nevada. There is little need to reprint them here. It is all too familiar -- a rehash of the rabid "robed and unrobed" views, opinions, pledges and commitment of every right wing organization and ultra conservative fanatic in

Brown, who holds a degree in Theology, is employed as a co-ordinating agent at the Opportunity Training Center in Los Angeles and, to say the least, is confused and dismayed at his reception in "The Best City Of Them All".

"Survival Of Black People" Conference Set

The Las Vegas VOICE has never engaged in the popular game of "Bait the Police -Chief - or Sheriff". The arrest and jailing of Professor Brown was first reported to the VOICE by local religious associates of the young man. It was, however, erroneously reported that he had been arrested by City Police. As is customary, this was checked with the LV Police Department and it was learned the City was not involved.

WE REQUESTED a statement from Brown detailing the entire circumstances of his arrest. His statement is offered here verbatim. There have been many inquiries at the VOICE office as to what action should or could be taken.

It is indicated, in our opinion, that Sheriff Ralph Lamb personally investigate the action taken by his deputies. Perhaps he can provide answers to the questions being posed on this unfortunate affair.

Here is Professor Brown's unedited version of what happened to him.

My plane arrived at 10:17 p.m. May 6. It was a TWA. At 10:45 p.m. I asked the officer, sheriff's officer, as to the directions from the airport to the Westside, and how long would the car trip take.

I made two calls of which I got no answer from either party. I then asked one of the employees of the airport concerning the next limousine.

At 11:45 p.m., I called the Church of God In Christ of which Bishop Cox is pastor. I received no answer from the church. I went to the coffee shop, purchased some snacks and after eating I spoke to the patrolman the second time. He asked of my destination and my business in Las Vegas, and who was I trying to contact. He concluded the questioning by asking my name and

After waiting another 35 to 40 minutes at the passenger loading area, I went back into the main area of the airport building at which time the officer, the same officer, stopped me and asked to see my identification. After showing him my hospital card, insurance identification card, letter of recommendation from my pastor, he pronounced them all to be invalid, and insufficient for proper identification. He asked for my draft card and drivers license. I had neither by reason of my visual difficulties. I also explained to him that my selective service registration card had been stolen earlier last year in a robbery committed on my person, and never recovered the wallet, although the robber was apprehended.

After this I was taken to the sheriff's police station at the second level of the airport building. After making a few calls I was then informed of my "constitutional rights", then placed under arrest as vagrant, idle and destitute in the county of Clark. I was frisked and handcuffed.

A call was made to Los Angeles concerning my police record. I had nothing more than a walking violation. Shortly afterwards, two other officers came, and with the arresting officer escorted me to the Clark County Jail, where again I was searched, all valuables taken from me in the customary manner; then stripped and sprayed like a common lousy criminal; placed in a cell and heckled about my religious convictions by the other officers. The heckling was short lived after my intelligent replies.

At 4 a.m. I was booked and fingerprinted and (See ARREST, page 4)
