**Murder Will Out**

DENVER--(NPI)--Here in the Mile High City last week, it was revealed by a news reporter for radio station KTLN, Bill Gagnon, a story of violence had been hushed successfully for almost two weeks for unknown reasons. It is said both the daily press and the city administration knew of the incident.

The story goes that on April 30, an assistant city Atty. Gerald Himelgrin, 43, admittedly "dumped" a six-year-old Negro youth to the floor at the Jewish Community Center, with sufficient vigor and the also admitted expectation that the boy remain there until he return--which the child did.

A CIVIL suit is to be filed against the attorney, and he has been suspended until further notice. The child is believed to be recovering from the ordeal after at least two trips to Denver General hospital.

The story hangs together with near piecemeal facts since the alleged incident occurred, and was hushed until May 13 when Station KTLN revealed it.

It was only after KTLN's disclosure of the incident that both daily papers carried accounts of it--in their May 14 editions.

**Negro Air Force General Command Widens Aug. 1st**

WASHINGTON - (NPI)--Lt. Gen. Benjamin O. Davis will take over command of the 13th Air Force in the Philippines on Aug. 1, the White House has announced.

He is now chief of staff of U.S. Forces in Korea and chief of staff of the United Nations' command there.

GEN. DAVIS, 54, whose father was the first Negro general in the U.S. Army, is the nation's highest ranking Negro officer.

A native of Washington, D.C., he attended school in Cleveland and went to Western Reserve University and the University of Chicago before graduating from West Point in 1936.

He had flight commands in North Africa, Sicily, and Italy in World War II.
