#### Peace & Power Advocates **Abandon Rights Struggle**

BOSTON - (NPI) -- The NAACP has charged that non-Negroes' participation in the struggle & for racial advancement has been limited, if not excluded, by young black activists seeking "refuge in racial isolation."

In its annual report, the NAACP also said many young white people had left the rights movement to work in the peace movement.

Despite these losses for rights movement, the NAACP said it had gained membership and income in 1966.

NOTING THAT civil rights legislation was killed last year by Senate filibuster for the first time in nine years, the organization charged that "neither the peace advocates nor the black power advocates nor the rioters attempted to mobilize support for the legislation.

"That burden was carried almost solely by the NAACP. Some of the erstwhile supporters of civil rights legislation, both Negro and white, completely abandoned ... the bill. They were in hot pursuit of other objectives.'

Rev. Donald M. Clark was elected Chairman of the Board of Operation Independence at the Board's election meeting Wednesday, July 12. Mrs. Margaret Quinn was reelected as 1st Vice Chairman and Peggy Smith will serve as 2nd Vice Chairman, Mrs. Leola Armstrong was reelected as Secretary and Ferrin Bunker was elected Treasurer. Neither former Chairman Larry Powell nor former Treasurer Sarah Ann Knight were candidates for re-election.

Last month at its Election of Officers meeting, the Economic Opportunity Board of Clark County elected Isaac White, Jr., Board Chairman; Emmet Lockett, 1st Vice Chairman; Father Shallow, 2nd Vice Chairman; Ted Lawson, Secretary; and Dorothy King, Treasurer.

#### Stock Exchange Figure

NEW YORK - (NPI) -- The first Negro has become a principal in a New York Stock Exchange member firm.

He is Clarence B. Jones, selected viceresident of the investment banking firm of Carter, Berlind & Weill, Inc., members of the New York Stock Exchange. At the firm, he will work in investment banking and brokerage and will have legal responsibilities.

A member of the New York bar, Jones has been a special counsel to Dr. Martin Luther King, Jr., since 1962.

While becoming a principal in the firm, Jones was accepted as an allied member of the New York Exchange. Jones, 36, is a director and vice-president of the Lawyers Constitutional Defense Committee of the American Civil Liberties Union and the committee's former.
