## Electoral College Hit

WASHINGTON--Senator Alan Bible today called the Electoral College system for Presidential election "a pretentious runaround" and said the time was overdue for Americans to have a direct vote in selecting their nation's chief executive.

"Our nation was founded on the rights and freedoms of the individual," Bible told the Senate Subcommittee on Constitutional Amendments. "Yet we deny the validity of the individual vote when we choose our national leader."

"If there was ever a valid reason for the Electoral College, it certainly ceased to exist in the 20th Century."

The senior Nevada senator testified in support of a resolution to abolish the Electoral College--a proposed constitutional amendment which he co-sponsors. If approved by Congress, the proposal would go to the state legislatures for ratification.

Bible reviewed the major criticism of the Electoral College system--that it would be possible to elect a President who did not win an actual majority of the popular vote.

HE POINTED out the system no longer functions as it was originally intended by the framers of the constitution, and he charged there was no basis to the argument that a direct election would favor one or another section of the country.

"A direct election would favor the people--it's as simple and straightforward as that."

The Electoral College "may have been a useful device in early times when transportation and communication among the fledgling states were slow and difficult. But we live in an age of instant electronic communication when almost every citizen has full opportunity to know the candidates and understand the issues."

But the most serious indictment against the Electoral College, Bible added, was that it sidetracked the individual vote.

"The indirectness of choosing electors to vote for the nation's leaders casts doubt on the very competency and intelligence of our citizens," Bible said. "It's as if we didn't trust the people first hand."

Bible said it was time to "quit hedging on democracy."

"Congress should offer Americans a direct voice in the Executive as well as the Legislative branch of their Government," he concluded.

## Protection Against Uninsured Car Owners

Financial protection against the uninsured or hit and run driver will be offered with all automobile insurance policies sold or renewed in Nevada beginning August 18, 1967, Louis T. Mastos, Nevada Insurance Commissioner said today.

Mastos explained that legislation enacted this year requires companies providing automobile insurance in the state to offer this protection with all car insurance policies, although policyholders may reject the coverage if they desire.

WITH UNINSURED motorist protection, a driver's own insurance company will pay for bodily injuries suffered by him for which a motorist who does not have automobile liability insurance and who cannot pay the damages is held legally liable. It also pays for injuries caused by hit and run drivers.

All the members of a family residing in the same household are covered, even while walking or riding a bicycle, the Commissioner said.

The coverage pays hospital and medical bills, loss of wages or other income and other costs related to the accident up to a limit of \$10,000 for each person injured and \$20,000 maximum per accident. These limits were established by the Nevada Legislature, Mastos noted.

Uninsured motorist protection, which costs about seven dollars per car per year, has only been available in the past on an optional basis, the Insurance Commissioner said.
