proval of the NAACP membership.

The NAACP charges that Negro members of local #226 are held in virtual servitude by Al Bramlet, local union head, and denied proper voice in determining wages, hours, and working conditions.

Attorney Chas. L. Kellar, President of the local NAACP Chapter announced to the group that he would be meeting with National and Regional NAACP representatives next week at the NAACP Regional Conference at Asilomar, California. He said that at that Conference he will be working with members of both the National and Regional NAACP Legal Redress and Labor and Industry Committees to work out details of the decertification move.

KELLAR ALSO announced plans to hold conferences on the Westside, Oct. 20 and 21. One of these conferences, Kellar said, will be limited to Negroes only for the purpose of affording opportunity to all Las Vegas Negro residents, who so desire, to express themselves on all matters of community concern without fear of retaliation from Bramlet (if that be the area in which their grievances lie) or any other member of the power structure.

The final meeting of the conferences on Oct. 21 will be open to the press and to the general public, Kellar added. White NAACP members who were present at the meeting supported the program of closed and open meetings as it was outlined.

In answer to questions as to whether an all Negro meeting with the press barred would be construed as a "Black Power" meeting, the President expressed his feelings that there were many questions facing Negro citizens of Nevada that are not the business of the white power structure--that Negroes had the right to air their differences and quarrel among themselves in privacy. As example, Kellar pointed out, the question as to whether or not the NAACP speaks for the entire Negro community is one of the issues expected to be aired out at the closed meeting.

The local NAACP head's forthright stand to meet existing festering problems of disunity in the Negro community has met with near total approval. Exemplary of over-all concern are the instances of the relatively recent formation of Westside organizations (such as the Prometheus Circle headed by NAACP Secretary Floyd Plymouth) that have challenged the older es-

tablished Negro leadership.

ANOTHER FACTOR of note at Sunday's NAACP meeting which carried an unusually heavy agenda was introduced by Rev. Donald M. Clark, Chairman of the Operation Independence Board, who voiced strong opposition to the present leadership of a county-wide Con on Housing, Education, Employment and Training, and Police Community Relations slated for Nov. 4 at either Convention Center or at Nevada Southern University.

Rev. Clark raised objections to the planned Conference on his premise that the 40 persons who adopted the suggestion for the Conference Plan and Program at a meeting held at Doo-little Center, Wednesday, Sept. 6 were not representative of the Westside community.

However, subsequent to Rev. Clark's departure from the meeting, a motion authorizing the NAACP to participate fully in the Nov. 4 Conference was unanimously adopted.
