
Mayor Gragson been puttin' in so much time

# WHEN A FELLOW HUMAN BEING NEEDS A FRIEND



Desolate as the bare rooms of their home at 1805 Nelson Street are three of Mrs. Joan Walker's four children as they view, in numbed bewilderment, their empty house after the Dial Finance Company had stripped it of all furnishings, Monday.

Mrs. Walker's tragic situation was uncovered by a Neighborhood Council worker who reported it to the Neighborhood Council's Project Director Lamar McDaniel. McDaniel, reminded of a statement made by District Attorney George Franklin at an Equal Opportunity Conference only days after his election, that he was particularly concerned at the type of business practice that victimized the poor, referred Mrs. Walker to the District Attorney's office. There, she was told it was not in their province. (The writer regrets that the case was not brought to the personal attention of the District Attorney because the writer was also present at that conference and was impressed with the D.A.'s expressed concern in this area.)

### Discrimination Charge Against NSU Probe

An investigation of alleged discrimination against Title V students at Nevada Southern University will be welcomed, even encouraged, Dr. Bert Babero told the VOICE this week.

Dr. Babero, a Zoology professor at the University, is also a member of the State Equal Rights Commission. He said that a meeting had been held at the University between the Dean of Faculty, Jerry Crawford, Mrs. Ruth Berg, a Title V technician, and himself subsequent to last week's report that two students had filed charges of discrimination with the Equal Rights Commission.

AS A member of the Commission, Dr. Babero said he would push to the fullest extent for a complete investigation. He added he was confident that Dean of Faculty Crawford and Chancellor Moyer share his conviction that the University must be absolutely certain there is no semblance of racial prejudice on the part of any staff member against any student matriculating at the University or against other staff members.

Dr. Babero said that, hopefully, an investi-(See NSU page 16)

MRS. WALKER has been scarcely able to provide for her family on the ADC funds by which they exist. There is a husband, father of three of the children, who has deserted the family, and manages to avoid responsibility to them. Described by everyone who has met and talked with her as an intelligent, stable woman of character, Mrs. Walker has been engaged in a course to provide her training and skills to raise her employability standard in order to make an independent living for her family.

Schedule of the Committee's agenda includes a conference with Manpower Personnel on the subjects of off-base housing, utilization of Negro personnel in Armed Forces, Department of Defense policies on promotions, Negro soldiers in Vietnam, Project Transition, and Military draft.

Subsequent to a meeting with Secretary of Defense McNamara tomorrow (Friday) morning, the publishers will depart by helicopter for the Aberdeen Proving Ground where they will lunch and later observe firing and equipment demonstrations.
