--"Thou shalt let him have his mess (For example, his own room, desk order).

-"Thou shalt not ever let the sun go down without making up arguments.

QUITE possibly it may be of value to you to consider these dictums seriously. The good Rev. Treacy has been married 35 years.

And, according to Mrs. Treacy, "He is a wonderful husband."

### EDUCATION ROUND-UP

CHICAGO - (NPI) -- School integration plans using buses have been protested by civil rights groups in two cities. In Chicago, the Coordinating Council of Community Organizations urged that federal funds be withheld from an integration program suggested by Schools Supt. James P. Redmond. The plan's racial quotas would discriminate against Negro children, CCCO said. In Providence, R.I., a school integration plan was protested by Negro parents, who said white, as well as Negro pupils, should be bussed. Like Chicago's plan, the Providence pro-gram attacks de facto school segregation-transferring 2,700 Negro pupils to 29 of the city's 39 elementary schools, so that no school has more than a 30 per cent Negro student body.

#### ACHIEVED

EVANSTON, Ill. - (NPI) -- School integration in this Chicago suburb was achieved in computer-like fashion this fall. And, unlike the situation in other cities, there seemed to be no objections. Evanston got instant integration by ruling that each school must have 17-25 per cent Negro school body and by bussing Negro pupils to accomplish that goal.

#### ONLY SIX

WASHINGTON - (NPI) -- "Integrated schools" are all right in their place, but I wouldn't want my daughter to attend one." That seemed to be the overwhelming view of the nation's Representatives and Senators, only six of whom send their children to public schools in the nation's capital. Other lawmakers send their children to private, parochial, or suburban schools, or institutions of learning back home.

#### FIRED

BALTIMORE - (NPI)--A white teacher has been fired for giving too much emphasis to civil rights in her 12th grade English classes. Mrs. Jody Johns was accused of "pre-occupation with racial issues and civil rights in her classes" at the predominantly Negro Edmonson High school, School principal Carroll Rankin said Mrs. Johns was not teaching her students to 'speak, write and read."


