## Youth Gang Leader Quells Incipient Riot

CHICAGO - (NPI)--A Southside gang leader is credited with almost singlehandedly putting down a racial disturbance that could have added Chicago to the list of riot-plagued cities.

Herbert (Thunder) Stevens, 20, who identified himself as a leader of the Blackstone Four Corner Rangers gang, told a milling crowd, that he wanted the streets cleared when he returned. The crowd, which had been set into motion by a black power rally, obeyed.

Two reported incidents of police brutality were said to have ignited the disturbance near Forrestville High School, whose rundown condition, according to community leaders, is enough to get anyone upset.

At least 51 persons were arrested and 13 injured in the outbreak.

## Mississippi Wheels Of Justice Grind To A Halt

JACKSON, Miss. - (NPI)--The wheels of justice grind slowly in Mississippi. More than three years after three civil rights workers were slain near Philadelphia, Miss., in 1964, 18 white men will go on trial Oct. 9 on charges of conspiracy in the deaths of Andrew Goodman, Michael Schwerner, and James Chaney. Among those to be tried in the courtroom of U.S. District Judge Harold Cox are Sheriff Lawrence Rainey; his chief deputy, Cecil Price, and Sheriff-elect E.G. (Hop) Barnett.

## And They Wonder Why The Freedom Cry Is Now!

ATLANTA - (NPI)--An Atlanta University dean has called for a study of the problems Southern Negroes have in gaining access to public libraries.

Writing in the Wilson Library Bulletin, Dr. Virginia Lacy Jones, dean, Atlanta University School of Library Service, said the study was especially needed because of the historic practice in Southern states of denying library services to Negroes.

"Now that the legal barriers to such practices have been surmounted," Dr. Jones wrote, "actual progress needs to be documented in terms of the benefits of library use that are being derived by Negro citizens."

The dean also called for a study of the promotion of Negro professional librarians and the policies that govern their appointment and promotion to high-level positions.
