ALL-OUT BOYCOTT OF ANDERSON DAIRY PRODUCTS URGED

One thing must be said for the Anderson Dairy Company, there is nothing hypocritical about the operators nor do they speak with forked tongue. Questioned about the report that the milk company had discontinued home service in the Negro residential area, the answer was a forthright, uncompromising "Yes". Reason given for the home delivery cut-off was that there were too many bad credit risks.

So who would be stupid enough to argue with policy of cutting off customers who don't pay their bills--BUT--whoever heard of a business that disdained the patronage of a whole segment of people because some of them are bad credit risks? Has this ever happened to any other category of customers, and there are classifications in all circles; the answer is certainly not.

THIS ACTION of the Anderson Dairy Company of blanket discrimination is as senseless as it is reprehensible, and it calls for immediate retaliation by every Negro (and every resident who claims a Negro as a friend) with an all-out uncompromising boycott of all products of the Anderson Dairy Company.

Asked if the Dairy still delivered to markets, schools, cafes and other outlets in the Negro community, the answer was in the af-

firmative.

The course of action against Anderson Dairy is a simple one. Make sure that every-

body knows about the company policy. Knowing it, it is certain that not a drop of their white milk will go down the mouths of black residents here or wherever the product is sold. Parents should immediately ascertain which dairy services schools and nurserys where their children are enrolled and every conceivable pressure should be brought to bear that purchasing agents of these institutions should cease doing business with the Anderson Dairy Company at once.

In righteous indignation our Anderson Dairy Boycott can make the Boston Tea Party seem as rebellious as a minority report at a Park and Recreation Commission meeting.
