

Janice Brooks was elected president of the Student Council in a General Election on Friday, October 6, 1967 by the student body of Madison Elementary School.

Janice, a sixth grade student in Mrs. Willie Bell Brown's homeroom, was victorious over five other candidates who were running for the office of president.

Other winners were Shirley McCullah (fifth grade), vice-president; Pamela Crockett (sixth grade), secretary; Willie Jenson (sixth grade), treasurer; and Ronnie Holmes (fifth grade), reporter.

A PRIMARY election was held in each classroom to determine candidates to run in the general election. Each candidate appointed his campaign manager. The managers developed placques, name cards, and slogans to aid their candidates.

The campaigns were in action for one week. Speeches were made by the candidates before the student body president, vice-president, and secretary on Wednesday, Oct. 4; Reporter and treasurer on Thursday, Oct. 5.

Mr. James L. Pughsley, principal of Madison School, stated that the campaign and election served as a means of teaching good citizenship to young people. They were experiences from which the students will benefit greatly, not only for the past week, but for the future as well. Mr. Pughsley and the Student Affairs Committee feel that the Student Council is vital to Madison School.
