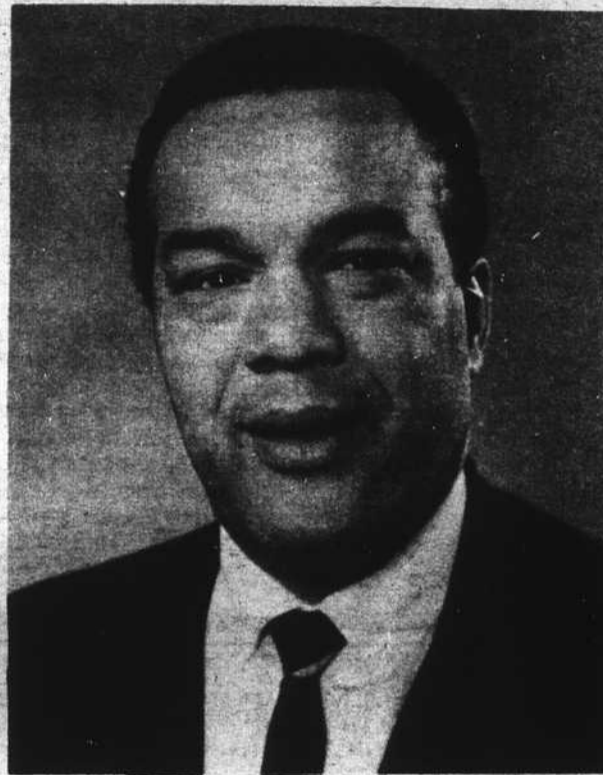

OEO & U.S. Departments Of Labor & HEW Officials To Spearhead NAACP Conference

The NAACP Branches Statewide Conference on Community Action Programs which takes place this weekend October 20, 21 (Friday and Saturday) at Doolittle Community Center, 'J' Street and Lake Mead Blvd., here in Las Vegas, should compel the attention and presence of all Negroes in the area.

The Conference is designed to give residents opportunity to air grievances and to address questions on a variety of public programs to individuals whose positions in the administration of the varied programs would validate them as qualified to offer acceptable answers.

Delegations from the three NAACP Branches existent in the State will participate in the Con-

ference. Clanton Williams, President of Mineral County Chapter (Hawthorne area) will attend with other representatives of that Branch, and the Reno-Sparks Branch President, Eddie Scott and other officers, will head their delegation.

Community Action, Legal, and Manpower experts from the Office of Economic Opportunity and the U.S. Labor Department will participate in panel discussions and workshop sessions scheduled for the Conference.

THE FIRST session of the NAACP Nevada Program For Action Conference will convene Friday evening (Oct. 20) at 7 p.m. with Attorney (See NAACP, page 4)

NAACP Sets Stage For Anderson Dairy Boycott

PLANS FOR an organized boycott of Anderson Dairy Products are underway, this week, by the Las Vegas Branch of the National Association for the Advancement of Colored People.

A slight delay in implementation of an organized boycott of the Anderson Company was occasioned by the absence from the City of Lamar McDaniel, NAACP Labor & Industry Committee Chairman whom Attorney Charles Kellar, NAACP President, has delegated the responsibility of spearheading the boycott.

McDaniel, who returned to the City Monday night from attending the funeral of his brother, has already begun to meet with various individuals and representatives of local organizations for an exchange of ideas on the mechanics "deep freeze" project.

There is a growing consensus among Negro residents of Las Vegas that if there is ever to be a meaningful development of the Negro

TROUBLE FOR AIRPORT LOOMS OVER SKYCAPS

Ceiling Zero is the forecast for McCarran Airport and atmospheric conditions are not responsible for threatening clouds hovering ominously overhead.

A mounting solidarity of support for the Airport's Skycaps whose livelihood is threatened is the center of the storm about to break.

The Skycaps' problem stemmed from the situation which arose when Western Air Lines chose not to renew its contract as the employer agency for the Skycaps when the present contract terminates Oct. 31. The Airport management accepted bids for the contract which was subsequently given to Allied Maintenance, a national firm that holds such contracts with a number of major airports throughout the nation.

ALTHOUGH Allied Maintenance is affiliated with the Brotherhood of Railroad & Steamship Clerks Union of which the local Skycaps are also members, it was learned the new agency was recruiting for Skycaps and the seniority of
