Officials of the Anderson Dairy Company met with the Southern Nevada Human Relations Commission Tuesday night and stated the Company's abrupt removal of home delivery service in the Negro residential community was motivated only by an insufficiency of business in the

area to warrant the service.

Company representatives also revealed to the Commission that a meeting had been scheduled for the following day (Wednesday) with representatives of the local chapter of the National Association for the Advancement of Colored People to discuss the threatened organized boycott of Anderson Dairy Products.

Unfortunately, the VOICE deadline precludes a report of the scheduled discussion on the issue.



Supreme Court To Hear Open Occupancy Appeal

WASHINGTON - (NPI)--The Supreme Court may make fair housing the law of the land this year, in the same way it outlawed segregated schools in 1954.

Just as a novel interpretation of the 14th Amendment to the U.S. Constitution brought the house down on jim crow in education, a 101-year-old Civil Rights Act may be invoked by judicial mandate, to require open occupancy.

The law was passed in 1866 to implement the 13th Amendment, banning slavery.

Housing segregation may be ruled unconstitutional on the basis of a clause in the Act, which declares, "All citizens of the United States shall have the same right, in every state and territory, as is enjoyed by white citizens thereof, to inherit, purchase, lease, sell, hold, and convey real and personal property."

THE COURT itself was integrated, for the first time in history, by Thurgood Marshall, who could be expected to lean toward a ruling favoring open housing by court decree.

To be considered by the court is an appeal which contends that the 1866 law should be invoked to require open housing. The appeal was filed by Joseph Lee Jones and his white wife,

Clarify Skycap Issue

McCarran Airport's Skycap Supervisor Ed Fly called the VOICE office to express, on behalf of the Skycaps, appreciation for community concern at the unhappy situation which has developed as a result of the contractual agency change-over.

Ed said that, in no way, has Western Air Lines let the Skycaps down. He explained that the whole hassle arose, months ago, when TWA began lobbying with other carriers for curb-side Skycap service. Western was perfectly willing to go along with the innovation if additional Skycaps would be hired to make the curb service feasible.

TWA was successful in winning over the other carriers at McCarran Field to support its demand for the service, without conceding to Western's plea for additional help mandatory for the service. Hence, Western Air Lines' relinquishment of the agency contract responsible for Skycap service and the resulting problem.

Western AIR LINES, Fly said, has been totally fair to the Skycaps during their whole

tenure of association.
