SEEK HELP

LOS ANGELES - (NPI)--By the end of the month October, the Most Rev. John Kwuao Aggrey, Catholic archbishop of Lagos (Nigeria), hopes to have secured sufficient financial assistance from Americans to help him provide "more teachers, missionaries and priests" to serve Nigeria's 8 million Catholics. The archbishop is currently in the closing weeks of his first nationwide tour of the United States, which began last Aug. 11. The senior archbishop in Nigeria, he is the first of three-Nigerians to become an archbishop.

PROTEST REMOVAL

ST. LOUIS - (NPI)--Charges that their involvement with civil rights activities led to their being asked by Episcopal Bishop George Cadigan of the Missouri diocese, to resign were made last week by the Revs. William L. Matheus and Walter W. Witte Jr., curate and rector respectively, of St. Stephen's church. The two clergymen said that pressure from wealthy Episcopalians caused the bishop to act on their "open alignment with ACTION," a civil rights group.

HITS NEW MORALITY

WASHINGTON - (NPI)--Robert H. Pierson, president, Seventh Day Adventist church, issued a warning at the annual autumn council meeting last week against the substitution of intellectuality for morality. He said, "The gleaming new age of technology has not made the slightest change in the nature of God or in His attitude toward right and wrong. In this fast-moving generation, we dare not find ourselves outdated, struggling valiantly, but perhaps hopelessly, merely to keep up."

HEARING

PHILADELPHIA - (NPI)--Objections to the renewal of the broadcast license of Station WXUR, of nearby Media, is presently being aired at a hearing of the Federal Communications Commission. Cast in role of objectors are the Greater Philadelphia Council of Churches, Anti-Defamation League of B'nai B'rith, Catholic Community Relations Council, American Baptist convention and the Pennsylvania Labor-Federation. Their complaint is that the station, operated by Brandywine-Main Line Broadcast, Inc., owned by Faith Theological Seminary, Elkins Park, Pa., is guilty of "highly racist, anti-Semitic, anti-Negro, anti-civil rights and anti-Roman Catholic" broadcasts.

VOLUNTARISM

CHICAGO - (NPI)--If a policy of voluntarism has not succeeded in desegregating Methodist annual conferences by 1972, a standby proposal is to be recommended to the church's 1968 General conference, that will make the target date a "deadline." The proposal was recommended last week by the Commission on Interjurisdictional Relations, while expressing the hope that "mergers within jurisdictions be...on a voluntary basis."

JAIL TERM FOR KING

BIRMINGHAM, Ala. - (NPI)--Dr. Martin Luther King, Jr., has indicated his willingness to voluntarily serve a five-day sentence growing out of a 1963 Easter demonstration. Dr. King and six other civil rights leaders were ordered arrested and jailed by Birmingham Circuit Court Judge William C. Barver after the U.S. Supreme Court twice upheld the leaders' sentences.

They had been convicted of contempt of court after violating an order not to demonstrate on Easter, 1963.

Sentenced were Dr. King; his brother, the Rev. A. D. King, Louisville; the Revs. Fred Shuttlesworth, Cincinnati; Wyatt Tee Walker, New York; and J. T. Porter, T. I. Fisher, and J. W. Haynes, all of Birmingham.

The demonstrators must pay fines of \$50 each in addition to going to jail.
