she knocked on and how many needy families she had reached in the 11 months she has served as Neighborhood Council Service Worker for the Highland School area.

Refusing to take any personal credit, she was proud of the work of the Neighborhood Councils and the activities of her own Highland Council. However, to her recollection, it was about 700 doors she had knocked on in the near a year duty as Highland's Service Worker from which number 75 families had been helped.

Mrs. Smith related one example of the total cooperation of the Highland Council. She had found a mother with nine youngsters in dire and destitute circumstances living in a two bedroom trailer on an income of \$106 a month. Adequate help was not available because the family did not qualify by tenure of residence at the time. (Tuesday of this week, Oct 24, marked this family's year of residence in the State). However, Mrs. Smith obtained medical care, food, and clothing for the family as well as advising them to the proper agencies to apply for needed services.

THE WARMTH and affection she feels for Highland Council members was revealed when she related their reaction to her report on the unfortunate family's plight. Immediately, members donated the sum of \$18 to send for the children's birth certificates. Subsequently, through the Council members' efforts, a total of \$92 was donated to move the family into better living quarters.

Mrs. Smith reported that the Council has started a Thrift Shop and will soon hold a bazaar to sell pin cushions, pillows and pillow cases, aprons, etc. (all made by the ladies of the Council) and profits of which are earmarked for a College scholarship for a deserving boy or girl whose family economic background precludes realization of the goal for higher education.

OTHER activities of the Council, reported by the Service Worker, included a Council sponsored picnic at Tule Springs for 35 underprivileged children and a chaperoned trip to the Shriners Circus at Convention Center for 12 delighted youngsters.

We salute Mrs. Smith and the Highland Neighborhood Council and are proud that they are a part of our community--"A gracious woman retaineth honour, and strong men retain riches"--Prov. 1:16.

Twenty-two Republican mayors have urged GOP leaders in Congress to continue or expand programs of the Office of Economic Opportunity by voting for the necessary funds.

A telegram on behalf of the group was sent by Mayor Neal S. Blaisdell of Honolulu to Senate Republican Leader Everett M. Dirksen and House Leader Gerald R. Ford.

Registration "Gimmicks"

CHARLESTON, S.C. - (NPI)--The NAACP is using old-fashioned persuasion in South Carolina, Louisiana, Ohio, Michigan, and Texas and a "big business" gimmick in Virginia to promote voter registration.

In Charleston, the organization launched a massive campaign to re-register the state's 190,000 Negro voters and add 60,000 new registrations. The state's potential Negro vote is 350,000.

The drive is being conducted this year in South Carolina because state law requires re-registration every 10 years. "Bread and butter with ballots" is the drive's slogan. Some 10,000 volunteers are expected to participate in the registration campaign.

NAACP voter registration drives also are underway in Louisiana, Ohio, Michigan, and Texas.

In Richmond, Va., E. L. Slade, NAACP president, joined forces with the Crusade for Voters to sponsor a Freedom Contest in which a total of \$425 will be awarded to registered voters. Those registering before Oct. 7, will be "eligible to win some hard cash," while gaining a say in their government, according to Slade.

More than 25,000 contest tickets have been printed to match the registration goal. Tickets are distributed free to registered voters at NAACP and Crusade for Voters headquarters. The winning tickets--offering prizes ranging from \$25 to \$200--will be drawn Oct. 16.
