
National Education Week Observance

Bible Hails Legislation On Age Discrimination

WASHINGTON--Senator Alan Bible called Senate passage of legislation against age discrimination in employment "perhaps the greatest single step toward assuring a happier, more useful and productive citizenry in our nation."

Bible, a member of the Special Committee on Aging and co-sponsor of the Age Discrimination in Employment bill, said it was important to note the legislation went beyond a simple ban on certain hiring policies.

"This act prohibits arbitrary age discrimination in hiring, but it also seeks to promote employment of older persons based on ability and attempts to help both employers and workers find ways of solving problems that stem from increasing age," Bible noted.

THIS BILL contains provisions for education and research on ways to overcome unwarranted policies against employing older persons and on methods of prolonging productivity. It also requires a study by the Secretary of Labor on the problems of involuntary retirement.

"It does not demand preference for older persons," Bible emphasized. "The bill seeks instead to assure equal consideration for employment and promotional opportunity to persons of all ages."
