## Las Vegan's Long Search For Family Ends Happily

Cleather Manning's story is perfect material for one of the daily soap operas which chain millions of housewives to their television sets five days a week. And though her story is not unusual in that it proves again that truth, indeed, is stranger than fiction, it is unique in that the end of the story is really a beginning. And a joyous beginning it is for the attractive, babyfaced mother of 8 who has just been reunited with the family for whom she has searched all her life.

CLEATHER WAS three years old when her mother died and her father, Ceolia Ellerson, left her with her maternal grandparents in Charleston, Missouri. Cleather remembers that her father must have kept in touch because, upon her grandmother's death, when Cleather was 14 years old, her heretofore unacknowledged resolution to find her father was somehow determined by the knowledge that her father had married again and that his wife's name was Lucile.

So at age 16, Cleather left home to begin the quest she never forsook. Her first stop was St. Louis where she thought she might find a lead to her Dad's whereabouts. Her grandfather passed when she was 18 and she broadened the search and took up residence in Benton Harbor, Michigan following a lead that her father was located in Michigan.

Then came adulthood and marriage and she moved to Los Angeles, California where she lived for 10 years while beginning a family of her own. But never did she give up hope of finding her Dad or members of his family. She knew he had a marriage previous to his union with her mother, so the name of Ellerson was ever her lead in the long search.

Five years ago, her husband, Joseph Manning moved the family to Las Vegas. He found employment at the Dunes Hotel where he is a porter, and they became a part of the local community engaging themselves in church and school activities. When the MANPOWER program was activated here, Mrs. Manning was employed as a Manpower Aide.

A devout christian, Mrs. Manning is a member of the Prairie House Church of God in Christ, and it almost seems natural that it was on a Sunday afternoon, last October, that Mrs. Manning found the trail that led her to the ful-

Mrs. Manning relates that she had returned home from church on that fateful Sunday and was sitting quietly in her home remembering places mentioned to her where someone had recalled an Ellerson family. Suddenly, she recalls, the name of Ypsilanti, Michigan kept crowding her mind, and she decided to call the Ypsilanti telephone information office only to find no listing for a Ceolia or Luella Ellerson. Unbidden, she related, the thought came to try the Police Department. A cooperative official found the City Directory revealed a Luella Ellerson residing there and dispatched an officer to the home with the message to call Mrs. Cleather Manning in

Two of the family necessarily missed the momentous occasion. One brother is in the Marines, another in the Army; both are in Vietnam. Brother Harold who is in the Navy was home on leave and was a part of the Ellerson family's storybook reunion.

Mr. and Mrs. Manning with their five sons and three daughters live at 609 Marcella, North Las Vegas. She is PTA President of Jo Mackey Elementary school where six of the Manning youngsters are enrolled. The other two attend J. D. Smith Junior High School. Mrs. Manning serves as President of her church Usher Board and the COIGC District Usher Board President as well. She is leader of the Junior Girls at Jo Mackey school and Jr. Mother of her church.

## **College Students Sought**

In an effort to motivate young college students towards careers in Federal government the Job Information Center in Sacramento (California) has opened a Student Trainee announcement appropriate to all Federal agencies in California and Nevada.

The announcement offers preprofessional training during the summer vacation to college students. Upon graduation, the students are than eligible for a continuing career position in their chosen field.

Practically all options of professional engineering are covered by the announcement as well as positions in the Life Sciences, Agriculture, Physical Sciences, and Accounting.

WHILE ON the job, student trainees will work under the guidance of professional personnel in the specialized field which the student has selected. Although working primarily under guidance, the students will have the opportunity to assist in working on various projects.

This opportunity should not be construed as temporary summer employment. Rather, persons selected will initially receive permanent appointments and will be eligible for professional positions upon graduation from college. They are retained on Federal rolls during the entire scholastic year in a leave without pay status and reemployed each summer.

Applicants for GS-3 level jobs will be rated eligible if they have at least one year of academic study completed, 30 semester or 45 quarter hours, and if they pass the written test. Eligibility at the GS-4 level requires at least two and one-half years of completed academic study as well as a passing test score. The GS-3 starts at \$82 per week while the GS-4 starts at \$92 per week.

The written test is designed to measure verbal ability in addition to quantitative and abstract reasoning. Candidates for the engineering and physical science positions will also be required to pass an algebra test.

Interested students should contact any of the seven Federal Job Centers in California and Nevada. The Job Centers in Nevada are located at 300 Booth Street in Reno, and at 300 Las Vegas Blvd. in Las Vegas. Test sites, which are located in 54 California and Nevada cities, will be listed in announcements received by contacting the Federal Job Centers.
