Stokey's Coming Back?

DAR-ES-SALAAM, Tanzania - (NPI)--Stokey Carmichael says he's coming home. But is he?

If so, the former SNCC chairman could face revocation of his passport--and thus might be restricted from leaving the country again. He also may be hit by arrest warrants for reportedly stirring up unrest.

Whether he would really want to return home to these woes and thus become a racial martyr remains to be seen.

Meanwhile, he was having his troubles in Africa as he tried unsuccessfully to unite Africa's Freedom Fighters with his black-power movement.

HE WON himself enemies when he declared that "Freedom Fighters don't fight. Their leaders are too interested in big cars and white women. Half of those leaders don't even know how to use a gun."

Carmichael's attack was answered by a spokesman for the African National Congress of South Africa, who said: "He excelled himself in meaningless and arrogant demagoguery."

The former SNCC leader, however, apparently had a "fruitful" meeting with Tanzanian President Julius K. Nyerere. And students at the University College of Dar-es-Salaam besieged him with requests for autographs after he eulogized the late Cuban Communist leader Ernesto (Che) Guevara.

Discriminating Citizens

WASHINGTON - (NPI)--A group of influential black people, rebuffed by the lily-white practices of area country clubs, are thinking of starting their own club.

Judge Aubrey Robinson of the District of Columbia Federal Court and Carl Rowan, former head of the United States Information Agency, are among those involved in the country club plans.

Rowan, who was once U.S. Ambassador to Finland, calls country clubs and other private clubs "the great symbols, the impregnable preserves of white supremacy today."

The black man may be a Cabinet member, federal judge, or Nobel Prize winner, he said, "but the white man, however lowly and unaccomplished, has got to have his exclusive club from which to thumb his nose."

ROWAN SAID his wife, who plays tennis with a group of Jewish women, "was appalled to hear them say that when they go to a certain posh club for the inter-country club matches, they change shoes in their automobiles because every effort is made to keep them out of the locker room."

While country clubs are off-limits to the former ambassador, he lives in D.C.'s predominantly white Northwest side and often goes to social parties largely attended by whites.

Still, he, Judge Robinson, and other distinguished black people must play golf on public courses, as they are not allowed to use country club facilities.

According to Judge Robinson, whites accept him as a friend but "stop short" of taking him and other black people to country club dances.

HEARTBREAK AFFORDED

SAN JUAN, Puerto Rico - (NPI)--A default judgment against Adam Clayton Powell has been won by his estranged wife, Mrs. Yvette Powell.

According to her lawyer, Arthur Newman, the judgment was granted by the Superior Tribunal Court because Powell failed to file an answer to Mrs. Powell's suit for separate maintenance.

In her suit, Mrs. Powell asks \$1,500 a month support for herself and her son, Adamcito, 5.
