Dr. West will return to Las Vegas January 4 and will be back in his medical office Friday, Jan. 5.

Proposed School Bond Is Of Major Interest To Us

Dr. James I. Mason, Superintendent of the Clark County School District held a press conference Tuesday morning and reported the "dire need" of six new junior high schools. Mason said that since the schools are presently working up to capacity, building expansion is the district's largest concern. The Superintendent has proposed a \$59 million bond issue vote to meet projected building needs.

The press conference was not covered by the VOICE as any news value it might have would be dissipated by VOICE press time. Moreover, a perusal of the Clark County School District's Nov. 4, 1967 release entitled "Achieving Integration In Education" indicates that the time is overdue for a formation of a West Las Vegas Parents-Citizens Committee to engage in a serious "study of the proposed \$59 million building referendum and curriculum changes in local schools" concurrent with that of the re-organization committee of 100 citizens which the Superintendent stated will be formed by Dec. 19.

ACCORDING TO Mason, the District's citizen committee will hold monthly meetings and the committee reports are scheduled for May at which time the board of trustees will study them and make further recommendations for the master plan, covering a ten-year period.

the master plan, covering a ten-year period.

It is the position of the VOICE newspaper that any future plans of the Clark County School District are of vital importance to pupils trapped by the circumstance of defacto segregation.

The recent report from the United States Civil Rights Commission on defacto segregated schools rang the alarm bell for those concerned with the educational development of millions of children.

The VOICE does not take issue with a proposed building referendum "in the neighborhood of \$59 million", but there is intense concern over the neighborhood future schools will be built. Neither would the VOICE impose its views for resolution of this very grave problem on the parents of the children involved despite the strength of the VOICE'S conviction on the problem.

The VOICE does, however, urge every parent and every thinking adult who are residents of a segregated neighborhood (by choice or not) to realize the gravity of the situation and, out of concern for the future of the children, to make this issue one of personal involvement immediately.
