est proposal, and their answers:

1. "Dr. Martin Luther King has announced plans for what he calls a 'massive dislocation' of northern cities, starting with Washington, D.C. around Easter to force Congress and the Administration to 'provide jobs or income for all'. Do you favor such an event?"

Answer: No, 71%; Yes, 12%; Don't know, 17%.

2. "Do you think that, as he has in the past, Dr. King can make a success of such a demonstration at this time, from the standpoint of numbers and keeping it non-violent?"

Answer: No, 56%; Yes, 23%; Don't know, 21%.

3. "If you could, would you go to Washington to participate in such a demonstration?"

Answer: No, 65%; Yes, 17%; Don't know, 18%.

4. "Washington now has a Negro Mayor and Negroes on the City Council. Do you think such a demonstration would be construed as a confrontation between them and Dr. King and would damage the Negro's image in any way?"

Answer: Yes, 76%; No, 10%; Don't know, 14%.

5. "The opinion has been expressed that 'massive disruptions' such as Dr. King plans would jeopardize President Johnson's chances of re-election since the people generally are tired of disorder, and would enhance the chances in 1968 of the Republicans. Do you want to see this happen?"

Answer: No, 84%; Yes, 4%; Don't know, 12%.

6. "Do you think non-violent demonstrations still potentially as effective a weapon against bigotry as they have been in the past?"

Answer: No, 72%; Yes, 13%; Don't know, 15%.

7. "Do you see any evidence of hardened resistance among whites to civil rights demonstrations?"

Answer: Yes, 81%; No, 5%; Don't know, 14%.

8. "Do today's civil rights demonstrations that you see on television or read about in the newspapers make you feel as proud of the demonstrators' conduct as you were in the past, during the Selma March, the March on Washington, the Birmingham and Albany, Ga., and Jackson, Miss. demonstrations?"

Answer: No, 51%; No, 14%; Don't know, 35%.

9. "Many people feel that Negroes are no longer committed to non-violence, that many take pride in being openly hostile to whites, that at any rate there is little likelihood that civil rights demonstrations can remain non-violent if opposed or harassed. Would you agree or disagree with this statement?"

Answer: Agree, 79%; Disagree, 8%; Don't know, 13%.

10. "It is said that Dr. King is suffering from a lack of ideas about how other than through demonstrations to power the civil rights movement, that he has had no real power base since leaving the Montgomery Boycott Movement to go to Atlanta and his Southern Christian Leadership Conference, and that he should move into the political arena and seek public office, or into Negro education or voter registration in the South. Do you find yourself in agreement or disagreement with this summation?"

Answer: Agree, 75%; Disagree, 11%; Don't know, 14%.

TREASURY DEPT. HITS SAVINGS & LOAN BIAS

WASHINGTON - (NPI)--Savings and loan associations, savings banks, and other organizations issuing and redeeming U.S. Savings Bonds and Savings Notes have been warned against discriminatory employment practices.

Assistant Treasury Secretary Robert A. Wallace, the department's equal opportunity officer, said S&L and similar institutions refusing to practice color-blind hiring will be de-

nied authority to issue or pay savings bonds and savings notes.

According to the Treasury department, posters announcing that "Discrimination Is Prohibited" must be displayed in these lending institutions, and their newspaper advertisements of job openings and employment agency solicitations must specify equal opportunity--or else.
