#### School Bond Proposal To Board Trustees

Members of the Clark County Board of School Trustees will be asked to act tonight (Thursday, Jan. 18) on School Superintendent James I. Mason's recommendation for approval of necessary resolutions to enable a May election on the question of issuance of \$59 million in bonds to finance construction of new schools, classroom additions to existing schools, rehabilitation and modernization of existing schools, and the purchase of necessary furniture and equipment for the schools.

Mason's recommendation was submitted to the Board in the form of an addendum to the agenda of tonight's regular Board meeting. If board members agree, Clark County voters will decide the bond issue at a May 21 election.

According to a statement by Superintendent Mason, the May 21 election date is essential in light of latest pupil population projections, which indicate the District will be unable to house approximately 10,000 pupils by the fall of the 1969-70 school year, the earliest date a new building could be opened.

Mason said, "If approved by the voters of

Mason said, "If approved by the voters of the county, the bonds would be issued over the next six years only as demanded by continuing growth of the community, which our consultants tell us will mean an increase in student population from the present 63,000 to an estimated 91,000 in the school year 1972-73. The bonds will be sold, and schools built, only as this growth materializes."

The School Superintendent also stated that "Accompanied by the predicted growth in assessed valuation, and by retirement of current bonds, the new \$59 million bond issue will not increase the current tax paid by Clark County taxpayers."

### NOTED ACLU OFFICIAL SPEAKS HERE TONIGHT

"Courts, Crime, Confessions, Cops, & Crackpots" will be the subject of an address by Lawrence Speiser, Director of the Washington, D.C. Office of the American Civil Liberties Union, tonight (Thursday, Jan. 18) at Nevada Southern University in Room #112 of the Social Science Building. Donation is \$1.00.

As Director of the Washington, D.C. Office, Speiser is the Union's lobbyist on Capitol Hill appearing frequently before Congressional committees on legislation affecting civil liberties and civil rights. In addition, as a lawyer, he has participated in a number of ACLU landmark cases in both federal and state courts.

A native of Toronto, Canada, Speiser attended the University of California at Berkeley from which he graduated in 1947 with a degree in physics. He then obtained his legal education at the University of California's Hastings College of Law where he served on the staff of the Hastings Law Journal and was elected to the national legal scholastic honor society, Order of the Coif.

FOR FIVE years (1952-1957) he was the staff counsel of ACLU's Northern California affiliate handling and coordinating its litigation involving challenges to various laws and governmental actions infringing on freedom of speech, press, religion, due process and the

## WILL FIKE CANDIDACY UNIFY NEVADA DEMOS?

Lieutenant Governor Ed Fike's announcement, this week, that he will seek the Republican nomination for the United States Senate seat of Nevada's senior Senator, Democrat Alan Bible, generated a surprising amount of interest in local political circles in view of the fact that the Lt. Governor's candidacy for the U. S. Senate was not unexpected.

Fike's announcement (made in Carson City Monday morning) in which he pledged "to wage one of the most thorough and intensive Senate campaigns in the history of Nevada--a grass roots campaign based entirely on the issues and going into every corner of the state" coupled with the fact that he immediately held a press conference in Reno Monday afternoon and one in Las Vegas on Tuesday, may well have been the stimulant Nevada Democrats needed to wake up to the fact that this is an election year.

Few will forget the vigorous campaign Fike waged when he won the lieutenant governorship with the largest number of votes ever cast for a lieutenant governor.

Nevada Democrats, who have been smarting from the stunning defeat handed them in the 1966 election when Republican candidates overcame a statewide two to one Democratic registration to take over the two top state positions, are said to be alerted by Fike's challenge to their 14-year representative in the Senate. There are those who dare to hope that Lieutenant Governor Ed Fike's candidacy will unite warring Democrat factions in the state. It remains to be seen.
