cided by excluding the tally in the Westside precincts, Nevada would have won the contest by more than 3000 votes.

The results of that 1964 balloting established the local Negro Block as the most loyal, most consistent, and most valuable stronghold in the Democratic party throughout the entire state of Nevada. This is a premise that defies intelligent rebuttal.

Clark County Democrats outnumbered Republicans in 1964 by nearly three to one. For every thousand registered Republicans, there were nearly three thousand registered Democrats.

THE WESTSIDE VOTERS WOULD LIKE TO KNOW why it took all of their votes, all of their party loyalty to give victory to a good Democrat. It is obvious that the majority of Democrats on "the other side of town" were traitors to the party. If the others had been as faithful as the Negro voters, Cannon would have won by thousands of votes. He actually won by less than one hundred votes. He won because the Negro vote did not jump party lines.

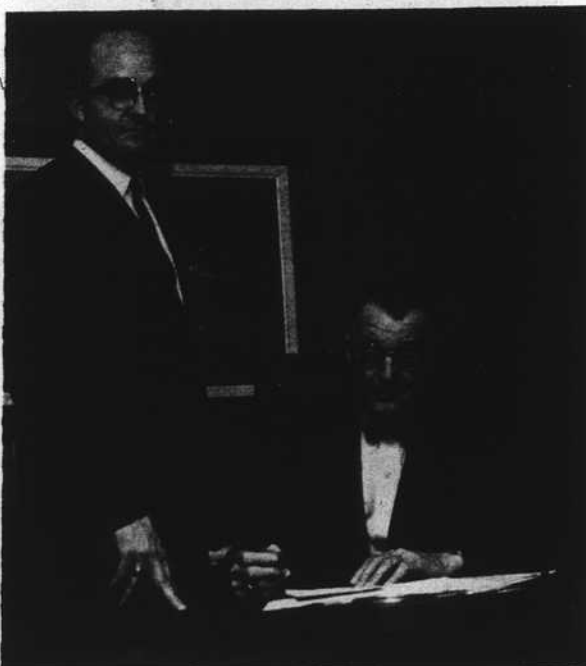

### Announce New Post Of Scientist-Assemblyman

### Third Man In Giles Case Still In Custody

ANNAPOLIS, Md. - (NPI)--Joseph E. Johnson, Jr., the third figure in the Giles brothers rape trial, continued to languish in prison after Circuit Court Judge E. Mackall Childs rejected his petition for a new trial.

Efforts to influence Gov. Spiro T. Agnew to pardon the 29-year-old defendant so far have been unsuccessful.

John and James Giles, convicted with Johnson in the rape case, were freed more than three months ago, when the U.S. Supreme Court ordered their case reopened.

The three were accused of being involved in the rape of a 16-year-old white girl in 1961. State Senator Thomas M. Anderson, Jr., a Republican, and Maryland Delegate Victor L. Crawford, a Democrat, asked the governor to pardon Johnson. They said it was "shocking" for Johnson to remain in prison, after the Giles brothers had been freed.

Gov. Agnew declined comment on the case, pending a formal request for a clemency hearing from Johnson's attorneys.

Meanwhile, Judge Childs dismissed every argument by Johnson's lawyers that the findings that led to freedom for the Giles brothers should also apply to the imprisoned man.

### Hobart Taylor Resigns Export-Import Bank Post

Hobart Taylor, Jr., has resigned as a Director of the Export-Import Bank of Washington to enter private law practice.

President Johnson named Taylor to the bipartisan Board of Directors on August 25, 1965 and following approval of the nomination by the Senate Banking and Currency Committee subsequently concurred by the full Senate, he was sworn into office September 20, 1965.

Taylor's resignation submitted to President Johnson became effective Jan. 31. The President's letter of acceptance commended his discharge of duties in the Bank Director's post and expressed the President's best wishes to Taylor as a partner in the Washington law firm of Dawson, Quinn and Riddell.

Born in Texarkana, Texas, Taylor was graduated from Prairie View College with a Bachelor's degree. He received a Master of Arts degree in Economics from Howard University and a Bachelor of Laws degree from the University of Michigan.

From 1964 until today, Taylor was Associate Special Counsel to the President. Prior to that time he served over three years as Special Counsel and Executive Vice Chairman on the President's Committee on Equal Employment Opportunity. In 1944-45 he was a research clerk to the Chief Justice of the Michigan Supreme Court. Taylor was in private law practice from 1945 until 1961, during part of which time he also served as County Attorney in the Wayne County Prosecutor's Office in Michigan.

Taylor is a member of the Bar of the U.S. Supreme Court, the Federal Bar Association, the Economic Club of Detroit, the University of Michigan Club of Detroit, the Detroit Press Club, and the National Lawyers Club.

### African Royalty Studies At Jackson State College

JACKSON, Miss. - (NPI)--The current student body at Jackson State College finds itself rubbing shoulders with another member of an African royal family. The newest member is Prince Harrison Lewanika, Barotse, Province, Zambia, who is the nephew of the present king Barotse, and son of the former ruler.

A history and political science major, he is following his eldest brother, Arthur, a 1964 graduate of the college, who now serves as a high school principal in the eastern province of Zambia.
