Mexican-Americans Can't Wait For Manana Either

SANTA FE, N.M. - (NPI)--Mexican-Americans are developing their own version of the civil rights movement in the mountains and desert areas of the Southwest.

The Spanish-Americans' leader, Reies Tijerina, is in jail, but he is not forgotten. The armed assault on the Rio Arriba County courthouse at Tierra Amarillo last June 5--in which Tijerina was identified--has become a subject of ballads and calvoso ditties.

of ballads and calypso ditties.

That attack has been called the Mexican-Americans' version of the "long hot summer."
Yet, Tijerina says he does subscribe to the violence which has occurred. His assertion is reminiscent of the "nonviolence" preached by some civil rights leaders amid mounting threats of interracial strife.

Tijerina is being held without bond in the courthouse case, which he is appealing. He already has been convicted in Federal Court of having participated in the seizure of a northern New Mexico national forest campground in October, 1966.

Like Dr. Martin Luther King, Jr., Tijerina has become a legend among his people. But Dr. King's "dream" of interracial harmony contrasts with Tijerina's efforts to claim hundreds of thousands of acres in private or government land and to try to establish his own independent nation on the land.

In this respect, the quixotic organizer of the "Federal Alliance of Free-City State" is more like the black nationalists. Offering dazzling promises, Tijerina is similar to the nationalists in another way: He has helped bolster Mexican-American self-pride.

Thanks to Tijerina, his followers, who formerly kept out of politics and public life out of a feeling of inferiority, have developed a new sense of assertiveness and a desire for independence.
