There is no thrill better than when the big spawning Bass hit surfacerunning lures.

The brushy coxes right in Vegas Wash have been producing excellent thrills and creel limits of Bass caught by the above method. Try your luck in any of the coves and spawning grounds that you are familiar with. Stick to top-running lures cast into the brush in shallow

Social Security Changes New Medicare Provisions

Among the new provisions of the Medicare part of the New Social Security Amendments are two that are of immediate importance to patients wishing to claim reimbursement under Part B, the doctor's part. One provision sets a limit on the time in which a patient has to submit his claim. The other provision makes it easier for a patient to be reimbursed.

A patient who had medical bills in July, August, or September of 1966 for which he has not been reimbursed must submit his claim for reimbursement by April 1, 1968. Claims for bills for services furnished from October 1966 through September 1967 must be submitted by December 31, 1968.

Some patients may be holding their unpaid bills from 1966 because they think they must pay the bill before medicare will reimburse them. However, while this was true under the old provisions, it is no longer true under the new provisions," said Ed Cocks, Las Vegas Social Security District Manager.

Cocks explained that under the old provision, if the doctor did not accept payment from Medicare, the patient had to pay the bill before Medicare would reimburse him 80% after he had met his \$50.00 yearly deductible. Under the new provision, a patient may be reimbursed by Medicare if he submits an itemized bill, whether id the bill or not. Howe may still have Medicare pay the doctor directly if the doctor agrees to accept payment.

Cocks warned that those persons 65 and over who did not sign up for Medicare when first given the opportunity should do so during the current general enrollment period because it ends April 1, 1968. If they fail to enroll during the current general enrollment period, they will not have another opportunity until the next general enrollment period in January 1969 through March 31, 1969.
