REWARDED

ST. LOUIS - (NPI)--Fleet outfielder Curt Flood was rewarded for helping to boost the St. Louis Cardinals to the National League pennant and the World Series title in 1967, when the club agreed to pay him an estimated \$75,000 in salary for the 1968 season. Although No. 2, in the Redbirds' lineup, Flood batted .335, fourth best in the NL, while setting a league mark by playing 226 errorless games.

COSTLY INJURY

MIAMI - (NPI)--Winter baseball has proven to be costly for Baltimore Orioles centerfielder Paul Blair. Blair, who will miss the Birds opening day lineup, chipped a bone in his right ankle while playing off-season ball in Puerto Rico and was forced to wear a cast for several weeks. He still walks with a limp, and the club doctors have ordered him not to do any running during spring training until late March.

PICKETING

NEW YORK - (NPI)--Black power and anti-war activists joined forces last week to picket the (March 4) heavyweight fight between Joe Frazier and Buster Mathis in Madison Square Garden. It was reported that members of the W.E.B. DuBois Club picketed the bout--billed as the New York-Massachusetts version of the title--in protest of the "snatching" by "Whitey" of Muhammad Ali's (Clay) crown because he refused to be drafted into the army.

INTEGRATED PLAY

MONTGOMERY, Ala. - (NPI)--The U. S. Justice Department last week asked a three-man federal court to direct Alabama school authorities to schedule athletic competition between predominantly Negro and predominantly white teams, in compliance with an order issued March 22, 1967, requiring the 99 Alabama school systems to desegregate their athletic programs. The department pointed out that the school systems had adopted a policy of scheduling interscholastic contests with white teams playing other white schools and Negroes playing Negro squads. A hearing on the request to "integrate the playing field" is set for March 8.

"COMPLETE" PLAYER

NASHVILLE - (NPI)--Eldridge Dickey, 6-2, 190-pound quarterback at Tennessee A&I University last season, and the first round draft to become the first Negro quarterback in pro football. But the man whom college coach described as "a complete football player," said he would settle for playing any position that would help the Raiders repeat as champions.

AND SO IS WALLACE

MONTGOMERY, Ala. - (NPI)--Presidential candidate George C. Wallace denies being a racist, but some of his most avid supporters are. The former Alabama governor said he has never made "any remarks that reflected on any person because of his race."

Maybe so. But his backers from coast to coast are getting the message. One openly racist group of supporters, in fact, broke off from his campaign to form its own party.

The "frankly racist group" in Alexandria, Va., named itself the White party. Located in the town where slain Nazi leader George Lincoln Rockwell made his headquarters, the party's leaders said they are "principally interested in speaking out for the racist point of view."

"I would assume Wallace would frown on any group (of his supporters) being racist," said a member of the Alexandria group, in explaining its break with the Wallace bunch.

Elsewhere in the country, Wallace's backers knew what he was talking about as he ran his Presidential campaign on an anti-Supreme Court platform. And Wallace knew his lower-middle-class white audiences as he blamed race riots on "militants, revolutionaries, Communists, and anarchists."

He was greeted by applause when he said he preferred the ideas of cabdrivers and steelworkers to intellectuals "with pointed heads." And he knew what his nervous white followers were waiting to hear when he declared that he would "keep the peace" if he had to "keep 30,000 troops standing on the streets, two feet apart, and with two-foot-long bayonets."

"The so-called civil rights laws," the "non-racist" said, are really an attack on the property rights of this country and on the free enterprise system and local government. I would try to have them changed in Congress."

Wallace's admitted objective in all his "law-and-order" preachments was to siphon off support from Democratic and Republican candidates and thus have a deadlocked Presidential election thrown into the U.S. House of Representatives for a decision.

There, he could make a "deal"--or "covenant," as he prefers to call it--that could weaken the powers of the U.S. Supreme Court and advance the segregationists' cause.
