## Ingredients For Riot

OMAHA, Neb. - (NPI)--At a time when the entire nation is trying to absorb the report of the President's Advisory Commission on Civil Disorders, this city was the scene of an outbreak indicative of some of the underlying causes of unrest.

The presence of race-baiting George C. Wallace in this city, combined with the slaying of a black teenager by a white policeman, were blamed for sparking disorders at predominantly Negro Mann Junior High School on the Near North Side and elsewhere.

The trouble started, according to Ernest Chambers, militant black leader, when about 50 demonstrators, mostly young Negroes, were routed from a Wallace-for-President rally. The demonstrators reportedly had been pelting the speaker's platform with paper drinking cups, stones, and sticks.

During the night, 10 businesses were looted or damaged, and 13 persons were injured as rock-throwing incidents multiplied.

Police said Patrolman James Abbott fatally shot Howard L. Stevenson, 16, as the youth tried to enter a looted pawnshop the white policeman was guarding.

At Mann Junior High School, students reportedly left classes and began smashing windows and setting fires to grass and shrubs on the school grounds.

Nebraska Gov. Norbert T. Tiemann said he hoped the departure of former Gov. Wallace will signal a cooling of tempers.

### Marchers Outnumbered

WASHINGTON - (NPI)--More than 10,000 persons will be involved in Dr. Martin Luther King's spring demonstrations. But they'll be, not the marchers, but policemen and military men, who are expected to outnumber the demonstrators, and be better organized, too.

A standby Army communications and command post has been established at police headquarters since the anti-war demonstrations at the Pentagon last October.

Local policemen have been given special riot-control training and equipment, including Chemical Mace, an incapacitating gas. The 10,000 lawmen contrast with 1,500 military police and Alabama National Guardsmen, who were deployed for Dr. King's four-day march in 1965.

Major department stores, meanwhile, have hired extra guards to cope with demonstrations which might get out of hand. Public Safety Director Patrick Murphy met with the Building Owners and Managers Association on the possibility that a small incident at the demonstrations might balloon into a major disturbance resulting in considerable property damage.

Mayor Walter Washington also met with Justice department officials on plans for disorders.

Almost lost amid all the counter-measures was Dr. King, who reportedly is planning to begin his drive with 100 leaders, then bring in reinforcements of 3,000 "permanent" marchers, and thousands more on weekends.

Dr. King has said he would use disruptive civil disobedience only as a "last resort" in his effort to induce Congress to pass \$10 billion in anti-poverty legislation.

Two of Dr. King's top aides--the Revs. Hosea Williams and James Bevel--will help plan the "poor people's campaign."
