"On The Record" Comment SUNDAY'S DATE -**On "Cabbages & Kings"**

It was none other than Thomas Jefferson who voiced an opinion (in a letter to Henry Lee in 1824) that "Men by their constitutions are. naturally divided into two parties: 1. Those who fear and distrust the people, and wish to draw all powers from them into the hands of the higher classes. 2. Those who identify themselves with the people, have confidence in them, cherish and consider them as the most honest and safe, although not the most wise depository of the public interests. In every country these two parties exist; and in every one where they are free to think, speak, and write, they will dealars the machine ''

declare themselves." The wisdom of Jefferson's commentary, more than a century ago, was significantly brought home to the Keynoter as events of the past week hurtled fatefully on to their inevitable destiny.

The Wednesday night board meeting of Operation Independence is a point in fact. Members of the executive board doggedly and ruthlessly kept their commitment to each other to "get rid of George Gant," Director of Operation Independence's ManPower Development Center, who had committed the unpardonable sin of being competent, dedicated, and a stimulant to the community. But, because the ManPower project is a federally funded community action program, no one could deny the public the right to attend. The public saw the viciousness, the vindictiveness, the deadly venomous of the self-

appointed community leaders laid bare. AS A RESULT, "the people have declared themselves" as will be evidenced by their actions in forever ridding the community of this damning and damnable influence. (The O.I. --Gant story is far from over).

Over the week-end, a delegation of committed Democrats journeyed to Reno to the Democratic State Central Committee. Through determination to "hang tough" together after having thoroughly done their 'homework', they were victorious in their goal to return control of the state's Democratic Party to the "people".

It is noteworthy that there was no jubilance evinced by the winners; rather there was an over-all serious recognition of the responsibility that was theirs for the future. Much has been reported of the magnificent leadership of Assemblyman Flora Dungan with the anti-Flangas forces, and it is more than deserved. But also, no one who was a part of the delegation will forget the performance of Attorney Charles Kellar as chairman of the Clark County Negro Delegation. His conduct and ability were superb throughout the Convention and, at its most crucial point when the chips were down, he emerged the hero.

With a notable exception, the Clark County delegation were equally superb. They played it "cool" and utilized all the political savvy they really have. Selflessness was the characteristic evidenced by one and all. It was our Clark' County Negroes' "finest hour".

The proof that there is no substitute for "togetherness" is evidenced by the fact that six Negroes were elected to the State Central Committee, namely; Earle White, Jr., Dorothy King, Sarah Hughes, Amos Knighton from Las Vegas, Henry Turner from North Las Vegas, and Laymon Green from Henderson. Three Negroes will be part of the Clark County delegation to the National Convention in Chicago in August. They are Attorney Kellar, Dr. Chas. I. West, and Mrs. Gwen Weekes Rahner. Moreover, every Convention committee had able Negro representation from Clark County. The ''notable exception'' referred to earlier

was the defection of Rev. Prentiss S. Walker. There were two others, lesser known and of lesser consequence. More about the defection at another time.

Fair Housing Rally

The Clark County Fair Housing Committee will conduct a public workshop on the controversial "open housing" issue Sunday, March 24, at 3 p.m. in the multi-purpose room of Madison Elementary School; 1030. North 'J' Street.

J. David Hoggard, Chairman of the Fair Housing Committee, announced that Curt Moody, Executive Director of the Community Relations Conference of Southern California, has accepted an invitation to conduct and supervise this first workshop of its kind in the State. Those who attended the November Solutions Conference held at Convention Center will remember Mr. Moody and his "laying it on the line" address to the Conference on the subject of open occupancy.

Mr. Hoggard and his steering committee members are to be congratulated for this forthright approach to the issue of open housing, and particularly for their having obtained the services of Curt Moody for Sunday's session. Moody is probably without peer in his expertise as a formidable foe of opponents of fair housing legislation.

As Community Relations Secretary for the Pacific Southwest Region's American Friends Service Committee, Curt Moody's indefatigable efforts and ability in organizing grass roots human relations committees throughout Southern California, and the enviable reputation he had earned as a speaker to civic and religious groups on fair housing and human relations, inevitably led him to the role of lobbyist (for the Friends Committee) in Sacramento, California, on fair housing legislation. It followed, then, that when the state of California was torn asunder by the infamous referendum "Proposition 14", Curt Moody was chosen as Field Director by "Californians Against Proposition 14"

It is hoped that every concerned citizen will make it an especial point to be present at Madison School Sunday afternoon to hear Mr. Moody, and to join the band of proponents of fair housing legislation in an effort to build a skillful, knowledgeable force, locally, to successfully wage the battle for attainment of fair housing legally, and in fact.
