

New Employment Program

The Clark County Economic Opportunity Board (EOB) has been advised that it is eligible for funds from the Office of Economic Opportunity and the U.S. Labor Department totalling \$2,087,000 to establish and operate a Concentrated Employment Program (CEP) for low-income residents in Clark County, it was announced today by Mr. Isaac White, EOB Chairman.

The program is designed to combine under one sponsor and in a single contract all manpower development and training programs and services that are necessary to help an individual move from unemployment and dependence to self-sufficiency, and to better coordinate the delivery of these services by funding through a single source.

"While the EOB will be the prime contractor, the State Employment Service will be the major supplier of Manpower services," White stated. "We have received assurance of full cooperation from Mr. Alan G. Dondero, Director of the State Employment Security Department, and Mr. Bill Schultz, Employment Administrator." Other agencies equipped by experience in administering various aspects of Manpower Development programs will also participate, including the Vocational Rehabilitation Division, Clark County School District's Vocational and Adult Education Divisions, Bureau of Apprenticeship and Training, and delegate agencies of the EOB.

Funds for the program will be provided through a contract with the U.S. Department of Labor, Manpower Administration, acting for itself and the Office of Economic Opportunity. More than half of the funds will be provided through the Economic Opportunity Act, and the remainder through the Manpower Development Training Act, administered by the Labor Department.

"AS THE prime contractor the EOB will have the responsibility for coordinating the activities of all agencies participating," White said. "One of the prime functions of the CEP program is to ensure a more effective system than has been the case in the past, with individually-funded programs on a hit-or-miss basis."

"We will also call on Mayor Gragson and other mayors of the County, and labor representatives to help in carrying out the project," White reported. "It is essential that all phases of the program be understood by everyone involved, including potential employers and clients to be served by the program."

Funds for the program--which is to be in operation by the first of July--are in addition to on-going manpower program funding, such as Manpower Development Training (MDT) programs, On-the-Job (OJT) programs of the Bureau of Apprenticeship and Training, the Human Resources Development (HRD) program of the State Employment Service, and Neighborhood Youth Corps (NYC) projects operated by the EOB and Clark County School District. It is anticipated that the "outreach" functions performed by the EOB Manpower Project (administered by Operation Independence, Inc.) will be integrated into the CEP project.

"With the wholehearted cooperation of all agencies, we feel this program can do much to improve employment opportunities for many of the 28,000 poor people in Clark County," according to White. We want this to be a truly 'concentrated' program to provide complete manpower services, including training, job development and intensive supportive services, to those people who are unemployed or underemployed." Success will mean:

- * better service to the individual and improvement in individual success rates.
- * better control and coordination of Federal manpower programs, and greater achievement of program goals and objectives.
- * elimination of much of the difficulty for local government officials -- and program recipients -- in dealing with a multitude of agencies.
- * improved coordination at the local level of all employment and related services.

A preliminary planning grant will be available to assist in planning and implementing the project.

Cook eggs according to directions for your type electric egg cooker for 5-minute eggs. Plunge into cold water. Crack shells and gently roll eggs between the palms of your hands to aid in removing shells. Heat broth just to simmering and drop eggs gently into the hot broth. Blend rice, parsley, pimiento and butter. Place in individual serving dishes. Ladle broth and eggs over the rice.

Remember when using small appliances to turn the dial to the off position before removing the cord from the outlet.
