CHICAGO - (NPI)--Dr. Howard Thurman, dean-emeritus, Boston University Chapel and a veteran leader in Negro education, has been selected to receive the 1968 Gutenberg Award of the Chicago Bible Society. The 69-year-old Florida-born grandson of a slave, graduate of Morehouse Collete, and former professor at Howard University, will receive the award during the Society's 128th annual meeting on May 3.

MERGER STUDIED

DAYTON - (NPI)--Merger of 10 Protestant denominations into a "church truly catholic, evangelical and reform," was the prime object of the seventh meeting of the Consultation on Church Union last week. The potential merger, affecting about 25.5 million church members, is being carried on by the AME, AME Zion, CME, Christian Church, Methodist, Presbyterian Church in the U.S., Protestant Episcopal Church, United Church of Christ, and United Presbyterian Church in the U.S., with observer-consultants from more than 20 other religious groups, including Roman Catholics and Eastern Orthodox.

OFFENSE AGAINST GOD

SAN ANTONIO - (NPI)--In declaring his support of open housing Archbishop Robert E. Lucey of San Antonio, declared "discrimination in the selling, renting or leasing of a home is morally wrong because it is an offense against God." He added that such "also offends the human dignity of the person who is denied the right to buy a home simply because of his religion, color or race."

METHODIST SUPER

LIMA, Ohio - (NPI)--The new superintendent of the Methodist Church's local district--which includes 64-70 all-white congregations--is the Rev. Sumpter M. Riley, pastor, all-Negro Cory Methodist Church. His appointment, by Bishop F. Gerald Ensley, of the Ohio West area of the church, will become effective the day before Rev. Riley celebrates his 65th birth-day--which is June 10.

ENTERS ORDER

BARDSTOWN, Ky. - (NPI)--The first Negro to enter the order of the Congregation of the Resurrection is Brother Thomas Augustine Biven of Bardstown. The 300-year-old order is located in Dundas, Ontario, Canada.

GARY - (NPI)--A new, faster test for detection of sicle cell disease is in the works, thanks to successful testing of chemicals used in the projected examination process.

The new test was being studied at Methodist
