NEWTON, Mass. - (NPI)--Some may call it an "interracial marriage," but for Sen. Edward Brooke's daughter, Remi, and her white fiancee, all that's coming up is an "old-fash-ioned wedding," marked by an age problem, rather than racial overtones.

Miss Brooke's future husband, Donald R. Hasler, 18, isn't concerned about the racial issue at all. Neither is the 19-year-old brideto-be, whose father is black and whose mother is white. The couple apparently is simply too young to care about "racial differences."

The one obstacle in their way is, not race,

but the state law requiring young men between 18 and 21 to get parental consent before marrying. Had Hasler been a year younger, he would not have been allowed to marry--even with parental permission.

Apparently, this roadblock has been passed, as the couple plans to marry June 22 at the Massachusetts Senator's summer home on Martha's Vineyard.

Both Hasler and Miss Brooke are Roman

The prospective bridegroom is a freshman engineering student at Monmouth College, West Long Branch, N.J.

He plans to transfer to Northeastern University, Boston, which Miss Brooke now attends.
