married the Greek multimillionaire--not for

this or that respectable or unrespectable reason-but simply because she fell in love with

And is it not her own business why she married him--and not the world's?

A third focus of judgmental concern is Lewis M. Steel, an associate counsel for the NAACP, who was dismissed for writing an article accusing the U.S. Supreme Court of seeming to uphold the Black man's cause, while actually defending the white man's rights.

The article, entitled "Nine Men in Black Who Think White," appeared in the New York Times magazine.

I do not agree with Steel's thesis, but I think it as silly and dangerous of the NAACP to fire an employe whose publicly expressed opinions stir up controversy.

The NAACP's action--which lends credence to the charge that the organization is too circumspect to be of much value to Black Americans--calls into question the association's professed commitment to civil rights, one of which is to express one's mind.

Of course, it might be answered that the NAACP itself has a right to take actions without outside interference. True, but the organization denied a man his job, not for what he did, but for the opinions he expressed. It would have been different had the NAACP only disputed his views.

The Black athletes, Mr. and Mrs. Onassis, and Steel--all took actions which they had every right to take.

It does not serve the cause of propriety to condemn them for expressing themselves. Such condemnation merely makes propriety an op-pressive force and legitimatizes the charge that good taste is only a coverup for puritanical

No, good taste would say, "To each his own," and recognize over and recognize every man's inalienable right to his own pursuit of happiness.

And propriety would add: "To pass judgment on another person is to outdo him at whatever he may be doing wrong.
