NEGRO HISTORY BAFFLER

Today's Baffler will test you to see whether you are moving toward a "Crow-Jim" policy that rivals the "Jim-Crow" outlook of many whites.

"Crow-Jim," for those who don't know, is but the Black version of "Jim-Crow." Just as some whites feel that their well-being depends on excluding Blacks ("Jim-Crow"), some Blacks believe that their salvation lies in keeping whites out and putting them down ("Crow-

There are no right or wrong answers to the questions in this Baffler; just try to be honest and avoid giving answers just because they seem to be the expected response.

After taking the test, go to the scoring below to see how you rate on the "Crow-Jim" scale. Here's the quiz:

 Several civil-rights leaders believe that white policemen should be excluded from Black areas. How do you feel about this?

-- A. I agree. A white policeman in a Black area is bound to be oppressive.

-- B. It depends on the white policeman. There are good and bad policemen among both Blacks and whites.

-- C. The idea is silly, as white policemen are seldom brutal in their relations with Blacks.

2. Do you feel that these leaders' proposals are any more justifiable than the exclusion of Black policemen from white areas would be?

--A. Yes. When whites exclude Blacks, that's racial bigotry; when Blacks exclude whites, that's social justice.

-- B. One form of racial exclusion is no more defensible than another.

-- C. When Blacks exclude whites; that's racial bigotry; when whites exclude Blacks, they're watching out for their economic and social interests.

3. How would you react if a white family moved into your building or your block?



SCORING: Count 3 points for each A, 2 points

for each B, and 1 point for each C.

If you score 12-15, you appear to believe in a "Crow-Jim" policy. Your racial attitudes may be so extreme that they border on bigotry. You fail to see that it is no more defensible to stereotype and to collectively condemn one race than another.

If you score 9-11, you are neither a racial bigot nor an Uncle Tom. You admirably combine a sense of personal and racial pride with an ability to let your fellow man--of whatever race-stand or fall on his own merits.

If you score 5-8, you are too hard on your own people and too disposed to be partial to whites. Some people may call you an Uncle Tom. You need to recognize that putting Black people down is no indication of racial advancement and personal dignity. On the contrary, it is through respecting yourself and your own kind that you can learn that other people are human, too.
