The Black Prophet who promised to make "Las Vegas A Ghost Town" if his demands from The County Commissioners and The Resort Industry for Forty Million dollars were not met by July 4th, failed to keep his word. He promised to act after July 16th.

The demands were issued in "an ultimatum" issued nearly a month ago. The Prophet demanded that forty million dollars be spent in the following manner: ten (10) million to be spent on educational buildings, for black churches and trade schools with black staffing: an additional thirty (30) million be spent to de-velop an Ebony Strip.

The Prophet set forth a 30-day period for the Commissioners to vote approval of the money in an emergency session. No comments have been made by the selfstyled Black Prophet, or the County Commissioners. James Brown universally accepted as the nation's No. 1 Soul Singer, is fast becoming the nation's No. 1 Gold Singer. James J. Slattery, of Johnson, Lane, Space & Smith Co., Inc., a brokerage firm, presents Brown with a check for \$1,098,000, the amount raised through the sale of 200,000 shares of stock in his new franchise enterprise. The money will be used to establish Gold Platter, Inc., a national restaurant chain based in Macon, Georgia, where he was once a shoe shine boy.

The restaurants will operate under the James Brown Gold Platter name. A major policy of the company will provide employment and investment opportunities to members of minority races. Stock was initially placed on sale July 9th, and is now being quoted in the over-the-counter market. The first Gold Platter franchise opened in June in Macon. A second restaurant is scheduled to embark late this month.
