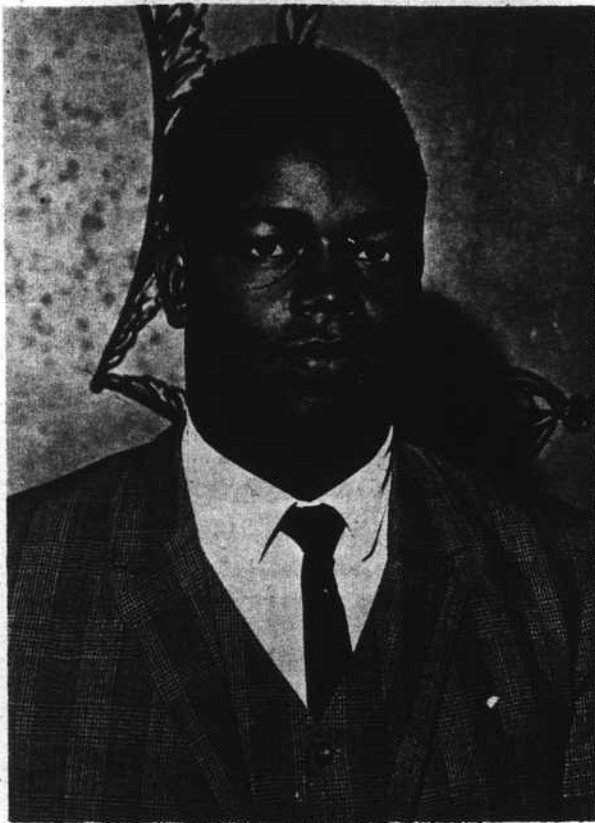

Federal Wage-Hour Law

San Francisco -- Nevada employers who violated the federal wage-hour law in 1969 were found to have owed a total of \$213,068 in back wages to 1,157 workers covered by the law.

Ken Hedberg, the department's wage-hour regional director in San Francisco, said almost all the amount was under the overtime provision of the law.

This requires time-and-one-half overtime for all work beyond a 40-hour workweek, and covers nearly all the 46-million workers in the U.S. to whom the federal wage-hour law applies. The overtime underpayment for 1969 in Nevada was \$202,846.

Hedberg said \$8,594 was accounted for in violations of the minimum wage provision, that requires \$1.60 an hour for most employees under the law. The clause requiring equal pay for the same work, regardless of sex, totaled \$496 last year. An additional \$1,132 was found owing workers by firms that violated the McNamara-O'Hara Service Contracts Act.
