League Of Women Voters

Presenting an introductory look at statesupported services for juveniles, League of Women Voters of Las Vegas Valley culminated the first phase of their study on Nevada juvenile services during the week of February 24th during a series of monthly unit meetings.

Tuesday, Wednesday and Thursday morning unit meetings were held at 9:30 am at 3671 Rosecrest Circle, 555 East Griffith and 301 Eldorado. Tuesday and Wednesday evening unit meetings were held at 7:30 p.m. at 323 Yosemite and 4650 Bridlewood Court.

Researching the facts and interviewing officials of health, welfare and rehabilitation service agencies took the ladies approximately one year under the chairmanship of Mrs. Hal Kearns, local juvenile services chairman.

Juvenile services is an item adopted for study by League of Women Voters of Nevada and will not only be presented to the local League but the Reno-Carson City League will also be conducting a series of similar introductory meetings.

Beginning in April 1970 specific areas of service described in the primary phase of study will be chosen for additional study and evaluation, out of which will come recommendations to the 1970 Nevada legislature.

League ladies will be making choices for direction of study from the categories of education, health, juvenile delinquency, mental health, rehabilitation and welfare. Sub-categories will include services for mentally and physically handicapped, preventative health services, correctional institutions, laws relating to drugs and their application to juveniles, alcoholism, day-care centers, hunger and others.

The League of Women Voters, in its 50th anniversary year of non-partisan service to voters, continues its program of concerted study and action on selected governmental issues.

Assisting Mrs. Kearns on her local committee were Mames Faye Cooper, Mildred Jacobs, Dorothy Matthews, Annette Mills, Hannah Reznick, Colleen Schroeder, Mary Ann Smith, Beth Tharel, Emilie Wanderer and Betty Weber.
