Wilkinson stated that he thought the board has done a tremendous job under present circumstances. By his resignation the board will lose one of its most esteemed members, a loss that will be felt in the community.

Just as they were pulling off he noticed a lady walking down the road toward the car.

Smith noted that she appeared quite flustered. She asked if he was going back to town and if

he would give her a lift.

At which time Smith stated that he was only going as far as Sugar Hill but he would be glad to take her that far. She came around the car and got in. About this time Walter noted a squad car approaching. As the patrol car came up behind him he tossed his beer can out. The officer came up to the car and asked if he Smith was drunk. Smith replied that he was not drunk. According to Smith's statement, the officer stated that he appeared drunk to him, and asked him to get out and place his feet apart and put his hands on the car. Smith obeyed, the officer frisked him and then began handcuffing him. Walter says that he asked why he was being handcuffed and was answered because he was drunk which Smith denied. He was led to and placed into the patrol car at which time the lady was asked to stand out of the car. Smith says he was driven to the NLV Police Station, upon his arrival at the desk Sargent station he saw the lady.

Use Of Mace Protested

The NLV Council Chamber was the scene of a protest against the use of mace by NLV Police. The police did not have sufficient instructions on the use of mace.

The Black Parents were more concerned because after the mace was used by the police, the follow up treatment was not employed ac-cording to instructions, which were read by councilman Aaron Williams. Several excuses for not following instructions was offered none of which seemed valid. Mayor Echols, stated that an attempt would be made to gather both sides for the next meeting June 15th.
