thing they chose to school. Specifically mentioned were hats, which some male students want to wear indoors, sandals for boys, and colored, sleeveless undershirts.

One group of students complained of a student council with no real power except what the school principal wanted them to have. They urged student government with power of its own outside and administrative guidelines.

McRobert and McMorris urged students with complaints to discuss them with their principal, saying that many problems brought up might exist in some schools, but not all.

They also told the students that they were proposing smoking lounges for students in all high schools. Under their plan, students would be allowed to smoke in the lounge only if their parents signed permission slips for them. They hope such lounges will end smoking in restrooms and other areas of the campus.

who would be attuned to the needs of the community. The decision of the board to disenfranchise the voters in Clark County was typical of past board actions and surprised no one," charged Pesner.

The writ of prohibition seeks to prohibit and restrain John F. Anderson from sitting as a member of the Board of Trustees of the Clark County School District and to prohibit Burnell Larson from further appointing any person to the Board to fill the vacancy created by the resignation of George Wilkinson.

The quo warranto action will determine the right of Anderson to sit as a member of the Board of Trustees of the Clark County School District.

The action was filed in the name of "Tex" King, the ranking senior member, and all other members of the union.

Pesner expressed gratitude for editorial support by all newspapers in the community, and noted that telegrams and phone calls are pouring in to the office in support of the union's position.

The writ of prohibition and quo warranto actions were filed by Robert L. Reid, attorney for the teachers union.
