the performance of the job in question. In certain cases, where there are job progression structures and seniority provisions for advancement, tests have been used at the entry level to predict ability to perform at the higher positions in the promotion ladder. The guidelines state that such tests are permissible only when "there is a high probability that persons employed will in fact attain that higher level job within a reasonable period of time."

With respect to employment agencies, the Guidelines cover not only tests given by the agencies, but also those tests which employers or unions ask the agencies to administer for them. The Guidelines state, "An employment agency or service will be expected to refuse to administer a test where the employer or union does not supply satisfactory evidence of validation."

The Guidelines urge employers, unions and employment agencies to provide an opportunity for retesting and reconsideration to earlier "failure" candidates who have availed themselves of more training or experience.

The EEOC's Guidelines were developed in conjunction with the Office of Federal Contract Compliance of the Department of Labor which will soon be issuing similar requirements for Federal contractors and subcontractors subject to Executive Order 11246.
