WHAT TO DO AT JUVENILE

1. Anytime a student is taken to Juvenile Hall, the parents should be contacted immediately.
2. In most cases the parents can go to Juvenile Hall at 3401 E. Bonanza Rd. (phone: 649-3611) and their child will be released into their custody.
3. If the juvenile is not released to the parents, they should immediately call the office of the Public Defender (phone: 384-5832) and inform him of the situation. They should request that he represent the juvenile at his "detention hearing." (a "detention hearing" is held before a judge to release a juvenile to his parents). You have a right to Legal Representation at this hearing. It is your responsibility to get it.

Westside Study Center

The Westside Study Center at Matt Kelly School, 1900 North J. Street, is open Monday and Thursday evenings from 6:30 to 8:30 p.m. for the benefit of black students who attend junior and senior high school outside their neighborhood.

The Center has an extensive collection of books and reference materials suitable for use by secondary students, and more will be added this year, according to Jerry Conner, Matt Kelly principal.

He said professional teachers will staff the Center to assist students with their work.

The evening study center was begun last year in response to requests from black students, who said they had difficulty using library facilities at their schools because of bus schedules. Matt Kelly was chosen as the location because it is centrally located and already serves as a community school, with an extensive list of programs for adults as well as students.
