EOB Emergency **Food Program**

You may be one of the 7,000 Clark County residents who meet the income criteria, and are eligible to receive Federal Surplus Com-modity Foods which are issued through the Department of Agriculture. These foods consist of cornmeal, flour, instant nonfat dry milk, evaporated milk, canned beef, canned pork, canned turkey, canned chickem, canned chopped meat, rolled oats, and wheat, shortening, cheese, bulgur, butter, purnes, raisins, rice, beans, peanut butter, lentils, instant mashed potatoes, apple juice, grapefruit juice, grape juice, orange juice, prune juice, green beans, peas, corn, scrambled egg mix, corn syrup, and infant formula additions of 30 cans of evaporated milk and 3 pints of syrup per infant.

These foods, in the quantity that the average low-income family would purchase, amount to approximately 11 percent of their monthly food budget.

According to statistics quoted from the "Federal Surplus Commodities Distribution Pro-gram, County of Clark," (April, 1970), pre-pared by the Division of Finance, County of Clark; In calendar year 1969 the average number of persons participating in the program was 1.851 per month. The peak month was December with 2,161. The total number of persons expected to participate during October, 1970, is over 4,000. It is generally agreed, however, that this is still only a small portion of the number of persons in Clark County who might actually be eligible for the program..." Already 12,232 persons have qualified for public assistance in Clark County has been estimated as high as 30,000.

The Economic Opportunity Board of Clark County has been funded for an Emergency Food Program which is designed to improve the effectiveness of the existing commodity program. The benefits which would result are that the agency responsible for the Surplus Commodity Food Program would become more concerned with needs of low-income people; needs which prevent them from fully participating in the benefits of food help programs, namely minimal knowledge concerning the availibility of the program, inadequate transportation, absence of knowledge concerning the income and shelter criteria. Cannon calls for lower interest rates

LAS VEGAS--A roll back in interest rates is necessary to stabilize the economy, Nevada Sen. Howard Cannon said here today.

Cannon said at a precinct meeting that the Nixon Administration's 'hands off policy toward the economy simply isn't working.' He said that Congress gave the President the power to control credit when necessary, but the President has not used it.
